

Dr. Chanelle Roberts, DDS is a general dentist at Capitol Dental and has previously worked at the Maryland Center for Aesthetic Dentistry.

While attending the University of Missouri-Kansas City (UMKC) she served her school and community through mentorship, leadership, and service activities. She served as the Vice President of UMKC’s chapter of the Student National Dental Association (SNDA), and as the Regions 4 and 6 Coordinator for the national SNDA organization. Yearly she helped plan and coordinate the schools MLK Day of service event which packaged and delivered thousands of dental kits to the community. She also was a founding member of the dentals school’s minority mentorship pipeline program.

Dr. Roberts is a member of the National Dental Association, American Dental Association, the Robert T. Freeman Dental Society, and the DC Dental Society.
