

A PROPOSED RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

---

To declare the existence of an emergency with respect to the need to approve multiyear Contract No. CW108413 with Acme Auto Leasing, LLC to lease vehicles to the District.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the “Multiyear Contract No. CW108413 with Acme Auto Leasing, LLC Emergency Declaration Resolution of 2024.”

Sec. 2. (a) The Office of Contracting and Procurement, on behalf of the Department of Public Works, proposes to enter into a multiyear contract with Acme Auto Leasing, LLC to lease vehicles to the District.

(b) The not-to-exceed price for the term of this multiyear contract with Acme Auto Leasing, LLC is \$9,690,700 for the three-year period of performance.

(c) Approval is necessary to allow the District to receive the benefit of these vital services in a timely manner from Acme Auto Leasing, LLC.

(d) These critical services can only be obtained through an award of the multiyear contract with Acme Auto Leasing, LLC.

33           Sec 3. The Council of the District of Columbia determines that the circumstances

37           Sec. 4. This resolution shall take effect immediately.
