| 11 | Section 1. Section 871.015, Florida Statutes, is created |

| 13 | 871.015 Unlawful protests |
| 14 | (1) As used in this section, the term: |
| 15 | (a) "Funeral or burial" means a service or ceremony |
| 16 | offered or provided in connection with the final disposition, |
| 17 | memorialization, internment, entombment, or inurnment of human |
| 18 | remain or cremated human remains. |
| 19 | (b) "Funeral procession" has the same meaning as provided |
| 20 | <u>in s. 316.1974.</u> |
| 21 | (c) "Protest activities" means any action, including |
| 22 | picketing, which is undertaken with the intent to interrupt or |
| 23 | disturb a funeral or burial. |
| 24 | (2) A person may not knowingly engage in protest |
| 25 | activities or knowingly cause protest activities to occur within |
| 26 | 500 feet of the property line of a residence, cemetery, funeral |
| 27 | home, house of worship, or other location during or within 1 |
| 28 | hour before or 1 hour after the conducting of a funeral or |
