A bill to be entitled

An act relating to false personation; amending s. 843.08, F.S.; prohibiting a person from falsely personating a firefighter or certain law enforcement officers if his or her action could deceive a reasonable person into believing that he or she was a bona fide official; amending s. 843.085, F.S.; prohibiting operation or ownership of a motor vehicle falsely marked in a way which could deceive a reasonable person into believing that such vehicle is authorized by a fire department for use by the person operating it; providing an exception; amending s. 921.0022, F.S.; conforming provisions to changes made by the act; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Section 843.08, Florida Statutes, is amended to read:

843.08 <u>False personation</u> <u>Falsely personating officer</u>, etc.—A person who falsely assumes or pretends to be a <u>firefighter</u>, sheriff, officer of the Florida Highway Patrol, officer of the Fish and Wildlife Conservation Commission, officer of the Department of Transportation, officer of the Department of Corrections, correctional probation officer, deputy sheriff, state attorney or assistant state attorney, statewide prosecutor or assistant statewide prosecutor, state attorney investigator,

29 coroner, police officer, lottery special agent or lottery 30 investigator, beverage enforcement agent, or watchman, or any member of the Parole Commission and any administrative aide or 31 supervisor employed by the commission, or any personnel or 32 33 representative of the Department of Law Enforcement or any other 34 criminal justice agency as defined in s. 943.045, whether federal, state, local, municipal, tribal, or territorial, if his 35 or her action could deceive a reasonable person into believing 36 37 that he or she was a bona fide law enforcement official, or a federal law enforcement officer as defined in s. 901.1505, and 38 takes upon himself or herself to act as such, or to require any 39 40 other person to aid or assist him or her in a matter pertaining to the duty of any such officer, commits a felony of the third 41 42 degree, punishable as provided in s. 775.082, s. 775.083, or s. 43 775.084. However, a person who falsely personates any such 44 officer during the course of the commission of a felony commits 45 a felony of the second degree, punishable as provided in s. 775.082, s. 775.083, or s. 775.084. If the commission of the 46 47 felony results in the death or personal injury of another human being, the person commits a felony of the first degree, 48 49 punishable as provided in s. 775.082, s. 775.083, or s. 775.084. 50 Section 2. "commission officer," "Wildlife Officer," "Marine Patrol Officer, " "marshal, " "constable, " or "bailiff, " or "fire department, " or by any lettering, marking, or insignia, or colorable imitation thereof, including, but not limited to, stars, badges, or shields, officially used to identify the vehicle as a federal, state, county, or municipal law enforcement vehicle or a vehicle used by a criminal justice agency as now or hereafter defined in s. 943.045, or a vehicle used by a fire department which could deceive a reasonable person into believing that such vehicle is authorized by any of the agencies described in this subsection above for use by the person operating the motor vehicle, unless such vehicle is owned or operated by the appropriate agency and its use is authorized by such agency, or the local law enforcement agency or fire department authorizes the use of such vehicle or unless the person is appointed by the Governor pursuant to chapter 354.

(4) Nothing in This section does not shall prohibit a fraternal, benevolent, or labor organization or association, or their chapters or subsidiaries, from using the following words, in any manner or in any combination, if those words appear in the official name of the organization or association: "police," "patrolman," "sheriff," "deputy," "trooper," "highway patrol," "commission officer," "Wildlife Officer," "Marine Patrol Officer," "marshal," "constable," or "bailiff, or "or "fire department."
