An act relating to the North River Ranch Improvement Stewardship District, Manatee County; amending chapter 2020-191, Laws of Florida, as amended; revising the boundaries of the district; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Section 4 of section 1 of chapter 2020-191, Laws of Florida, as amended by chapter 2022-244, Laws of Florida, is amended to read:
