37 Section 1. Paragraph (b) of subsection (19) of section  
 38 1001.03, Florida Statutes, is amended to read:

40 (19) INTELLECTUAL FREEDOM AND VIEWPOINT DIVERSITY

42 (b) The State Board of Education shall require each  
 43 Florida College System institution to conduct an annual  
 44 assessment of the intellectual freedom and viewpoint diversity  
 45 at that institution. The State Board of Education shall select  
 46 or create an objective, nonpartisan, and statistically valid  
 47 survey to be used by each institution which considers the extent  
 48 to which competing ideas and perspectives are presented and  
 49 members of the college community, including students, faculty,  
 50 and staff, feel free to express their beliefs and viewpoints on

 65 and statistically valid survey to be used by each state  
 66 university which considers the extent to which competing ideas  
 67 and perspectives are presented and members of the university  
 68 community, including students, faculty, and staff, feel free to  
 69 express their beliefs and viewpoints on campus and in the  
 70 classroom. The Board of Governors shall annually compile and  
 71 publish the assessments by December 31 ~~September 1~~ of each year,  
 72 beginning on December 31, 2024 ~~September 1, 2022~~.

76       (1) (a) A public institution of higher education may not:  
 77       1. Require or solicit a person to complete a political  
 78 loyalty test as a condition of employment or admission into, or  
 79 promotion within, such institution.  
 80       2. Give preferential consideration to a person for  
 81 employment by, admission into, or promotion within the  
 82 institution for an opinion or actions in support of:  
 83       a. A partisan, a political, or an ideological set of  
 84 beliefs; or  
 85       b. Another person or group of persons based on the  
 86 person's or group's race or ethnicity or support of an ideology  
 87 or movement identified under sub-subparagraph (b)1.a.  
 88       (b)1. A political loyalty test includes compelling,  
 89 requiring, or soliciting a person to identify commitment to or  
 90 to make a statement of personal belief in support of:  
 91       a. Any ideology or movement that promotes the differential  
 92 treatment of a person or a group of persons based on race or  
 93 ethnicity, including an initiative or a formulation of  
 94 diversity, equity, and inclusion beyond upholding the equal  
 95 protection of the laws guaranteed by the Fourteenth Amendment to  
 96 the United States Constitution or a theory or practice that  
 97 holds that systems or institutions upholding the equal  
 98 protection of the laws guaranteed by the Fourteenth Amendment of  
 99 the United States Constitution are racist, oppressive, or  
 100 otherwise unjust; or

101 b. A specific partisan, political, or ideological set of  
 102 beliefs.

103 2. A political loyalty test does not include fidelity to,  
 104 or an oath or effort taken to uphold, general and federal law,  
 105 the United States Constitution, or the State Constitution.

106 (2) The State Board of Education and the Board of  
 107 Governors may adopt rules and regulations, respectively, to  
 108 implement this section and establish penalties for a willful  
 109 violation of this section.

110 (3) If any provision of this section or its application to  
 111 any person or circumstance is held invalid, the invalidity does  
 112 not affect other provisions or applications of this section or  
 113 chapter which can be given effect without the invalid provision

120 (1) The Legislature finds that the advancement of  
 121 knowledge is the fundamental purpose of the State University  
 122 System and that such advancement is facilitated by the fearless  
 123 sifting and winnowing of a wide diversity of views and that the  
 124 open discussion and debate of contested public policy issues  
 125 from diverse perspectives provides essential preparation for

126 mature citizenship and an informed exercise of the right to

128 (2) For purposes of this section, the term:

129 (a) "Debate" means an event at which two or more  
 130 participants speak in favor of opposing approaches to the same  
 131 public policy dispute, after which each participant is allotted  
 132 time to address and rebut the position presented by the opposing  
 133 speakers.

134 (b) "Group forum" means an event at which two or more  
 135 speakers address a public policy dispute from divergent or  
 136 opposing perspectives, after which each participant is allotted  
 137 time to address questions from the audience and to comment on  
 138 the other speakers' positions.

139 (3) Each state university within the State University  
 140 System must have an Office of Public Policy Events and must  
 141 appoint a Director of Public Policy Events who is responsible  
 142 for the duties and reporting responsibilities of the office. The  
 143 office must, at a minimum:

144 (a)1. Organize, publicize, and stage debates or group  
 145 forums at the state university. These events must address, from  
 146 multiple, divergent, and opposing perspectives, an extensive  
 147 range of public policy issues widely discussed and debated in  
 148 society at large. The university shall sponsor no less than four  
 149 events each academic year. At least two events must occur during  
 150 the fall semester and at least two events must occur during the

151 spring semester.

152 2. Such debates and group forums must include speakers who  
153 represent widely held views on opposing sides of the most widely  
154 discussed public policy issues of the day and who hold a wide  
155 diversity of perspectives from within and outside of the state  
156 university community.

157 3. If the office is unable to readily find an advocate  
158 from within the state university community who is well-versed in  
159 a perspective, the office shall invite a speaker who is able to  
160 represent such perspective. The office shall, when necessary,  
161 provide such speakers who are not from within the state  
162 university community with per diem and a reimbursement for  
163 travel expenses.

164 (b) Maintain a permanent, publicly accessible, searchable,  
165 and up-to-date calendar in print, on the office's website, and  
166 on the state university's website listing all of the events  
167 sponsored by the office and all other debates, group forums, and  
168 events open to the entire campus community at the state  
169 university that address public policy issues. The calendar must  
170 itemize the title of the event, the name and institutional  
171 affiliation of the speaker or speakers, and the office,  
172 institute, department, program, or organization that sponsored  
173 the event, excluding those events sponsored by off-campus groups  
174 in rented state university facilities. Such calendars must be  
175 kept in the library system of each state university.

176 (c) Beginning September 1, 2024, and annually each  
 177 September 1 thereafter, provide to the Board of Governors a  
 178 report detailing the following:

179 1. The number of debates and group forums.

180 2. In chronological order, the calendars itemizing the  
 181 title of each event, the name and institutional affiliation of  
 182 the speaker or speakers, and the office, institute, department,  
 183 program, or organization that sponsored the event.

184 3. The number of enrolled students attending each event.

185 4. Expenditure information relating to any per diem or  
 186 reimbursement for travel expenses.

187  
 188 The report must reflect prior academic year statistics.

189 (d) Make publicly available, in an online format, a  
 190 complete video record of every debate and group forum organized  
 191 by the office. The video recording for an event organized by the  
 192 office must be posted on the office's website within 10 business  
 193 days after the event. Such video must remain publicly accessible  
 194 on the office's website for at least 5 years after the date of  
 195 the event. Such videos must also be permanently preserved  
 196 within, and made available to the public through, the library of  
 197 the state university that hosted the event.

198 (4) Upon approval of the board of trustees of the state  
 199 university and the Board of Governors, a state university may  
 200 assign the duties of the office to an existing administrative

201 office within the state university rather than establish a  
 202 separate office.

203 (5) Each office shall report directly to either the state  
 204 university's office that is responsible for compiling and  
 205 reporting the Integrated Postsecondary Education Data System's  
 206 graduation rate survey or Office of General Counsel.

207 (6) Each debate and group forum organized by the office  
 208 must be open to all students, faculty, and staff of the state  
 209 university and, unless restricting attendance to such event is  
 210 necessary to achieve a compelling governmental interest, to the  
 211 general public.

212 Section 5. Subsection (5) of section 1004.26, Florida  
 213 Statutes, is renumbered as subsection (6), and a new subsection  
 214 (5) is added to that section, to read:

215 1004.26 University student governments; the Florida  
 216 Student Association.—

217 (5)(a) The Florida Student Association is designated as  
 218 the nonprofit advocacy organization serving the needs of the  
 219 students of the State University System. If the Florida Student  
 220 Association fails to meet the requirements of this section, the  
 221 Chancellor of the Board of Governors shall designate an  
 222 equivalent nonprofit advocacy organization to serve the needs of  
 223 the students of the State University System with the approval of  
 224 the Board of Governors.

225 (b) The Florida Student Association shall be governed by a

226 board of directors. The membership of the board of directors  
227 shall be comprised of the 12 student body presidents of the  
228 state universities. The board of directors shall annually elect  
229 a chair from among the board's members. The chair shall also  
230 serve as president of the association.

231 (c) The Florida Student Association shall adopt bylaws to  
232 establish:

233 1. A due process for the removal or impeachment of the  
234 president of the association. Such due process must provide that  
235 the president of the association may be removed by the majority  
236 vote of members of the board of directors. The grounds for  
237 removal of the president of the association are limited to  
238 malfeasance, misfeasance, neglect of duty, incompetence,  
239 permanent inability to perform official duties, or conviction of  
240 a felony.

241 2. Procedures for the suspension and removal of the  
242 president of the association following the conviction of a  
243 felony.

244 3. Procedures for a president of the association who has  
245 been disciplined, suspended, or removed from his or her position  
246 to directly appeal such decision to the Vice Chancellor for  
247 Academic and Student Affairs for the Board of Governors. The  
248 bylaws may not place any condition precedent on the exercise of  
249 such right granted by this paragraph and the association may not  
250 elect a new president until the exhaustion of the appeals
