A bill to be entitled

An act relating to the Town of Lake Clarke Shores, Palm Beach County; amending ch. 57-1478, Laws of Florida, as amended; extending the corporate limits of the town to include portions of Edgewater Park and adjoining canals; providing an effective date.

WHEREAS, Section 2(c), Article VIII, of the State Constitution provides that municipal annexation of unincorporated territory shall be as provided by general or special law, and

WHEREAS, in Section 171.046, Florida Statutes, the Legislature recognized that enclaves of unincorporated territory can create significant problems in planning, growth management, and service delivery, and therefore declared that it is the policy of the state to eliminate enclaves, and

WHEREAS, Section 171.031(13), Florida Statutes, defines an "enclave" to mean any unincorporated improved or developed area that is enclosed within and bounded on all sides by a single municipality or any unincorporated improved or developed area that is enclosed within and bounded by a single municipality and a natural or manmade obstacle that allows the passage of vehicular traffic to that unincorporated area only through the municipality, and

WHEREAS, the Legislature finds that a certain portion of

Edgewater Park and adjoining canals, lying contiguous and adjacent to the present boundaries of the Town of Lake Clarke Shores, and comprising approximately 32.768 acres in land area, is a near-enclave, posing many of the inefficiencies and problems in planning, growth management, and service delivery that motivate the elimination of enclaves, and

WHEREAS, the Legislature further finds that there is no

WHEREAS, the Legislature further finds that there is no available statutory procedure to expedite the annexation of near-enclaves into the most appropriate incorporated jurisdiction, and that it is in the best interest of residents and visitors to this state that a special law be enacted for that purpose with respect to the Edgewater Park near-enclave, NOW, THEREFORE,
