 8 Be It Enacted by the Legislature of the State of Florida:

 10 Section 1. Sergeant Carl Mertes Street designated;
 11 Department of Transportation to erect suitable markers.-

12 (1) That portion of 125th Street between N.E. 8th Avenue
 13 and N.E. 9th Avenue in Miami-Dade County is designated as
 14 "Sergeant Cart Mertes Street."

15 (2) The Department of Transportation is directed to erect
 16 suitable markers designating Sergeant Carl Mertes Street as
 17 described in subsection (1).

18 Section 2. Detective Sergeant Steven E. Bauer Street
 19 designated; Department of Transportation to erect suitable
 20 markers.-

21 (1) That portion of N.E. 126th Street between N.E. 8th
 22 Avenue and N.E. 9th Avenue in Miami-Dade County is designated as
 23 "Detective Sergeant Steven E. Bauer Street."

24 (2) The Department of Transportation is directed to erect
 25 suitable markers designating Detective Sergeant Steven E. Bauer
 26 Street as described in subsection (1).

27 Section 3. Sergeant Lynette Hodge Street designated;
 28 Department of Transportation to erect suitable markers.-

29 (1) That portion of N.E. 127th Street between N.E. 8th
 30 Avenue and N.E. 9th Avenue in Miami-Dade County is designated as
 31 "Sergeant Lynette Hodge Street."

32 (2) The Department of Transportation is directed to erect
 33 suitable markers designating Sergeant Lynette Hodge Street as
 34 described in subsection (1).

35 Section 4. Full Gospel Assembly Street designated;
 36 Department of Transportation to erect suitable markers.-

37 (1) That portion of N.W. 40th Street between N.W. 2nd
 38 Avenue and N.W. 4th Avenue in Miami-Dade County is designated as
 39 "Full Gospel Assembly Street."

40 (2) The Department of Transportation is directed to erect
 41 suitable markers designating Full Gospel Assembly Street as
 42 described in subsection (1).

43 Section 5. Ebenezer Christian Academy Street designated;
 44 Department of Transportation to erect suitable markers.-

45 (1) That portion of N.W. 39th Street between N.W. 2nd
 46 Avenue and N.W. 4th Avenue in Miami-Dade County is designated as
 47 "Ebenezer Christian Academy Street."

48 (2) The Department of Transportation is directed to erect
 49 suitable markers designating Ebenezer Christian Academy Street
 50 as described in subsection (1).

51 Section 6. Bishop Abe Randall Boulevard designated;
 52 Department of Transportation to erect suitable markers.-

53 (1) That portion of N.W. 67th Street between N.W. 2nd
 54 Avenue and N.W. 4th Avenue in Miami-Dade County is designated as
 55 "Bishop Abe Randall Boulevard."

56 (2) The Department of Transportation is directed to erect

57 suitable markers designating Bishop Abe Randall Boulevard as
58 described in subsection (1).

59 Section 7. Jacob Fleishman Street designated; Department
60 of Transportation to erect suitable markers.—

61 (1) That portion of N.W. 81st Street between N.W. 7th
62 Avenue and N.W. 12th Avenue in Miami-Dade County is designated
63 as "Jacob Fleishman Street."

64 (2) The Department of Transportation is directed to erect
65 suitable markers designating Jacob Fleishman Street as described
66 in subsection (1).

67 Section 8. Reverend Winer Maxi Street designated;
68 Department of Transportation to erect suitable markers.—

69 (1) That portion of N.E. 73rd Street between N.E. 2nd
70 Avenue and N.E. 4th Avenue in Miami-Dade County is designated as
71 "Reverend Winer Maxi Street."

72 (2) The Department of Transportation is directed to erect
73 suitable markers designating Reverend Winer Maxi Street as
74 described in subsection (1).

75 Section 9. This act shall take effect July 1, 2013.
