

House Bill 1006 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED

AN ACT

1 To amend an Act relating to the Board of Education of Crawford County, approved
2 March 19, 1993 (Ga. L. 1993, p. 4136), as amended, particularly by an Act approved
3 March 10, 2012 (Ga. L. 2012, p. 4464), so as to reconstitute the board of education; to
4 change the description of the education districts; to provide for definitions and inclusions;
5 to provide for continuation in office of current members; to provide for election and terms
6 of office of subsequent members; to provide for automatic repeal under certain
7 circumstances; to repeal conflicting laws; and for other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **SECTION 1.**

10 Act relating to the Board of Education of Crawford County, approved March 19, 1993
11 (Ga. L. 1993, p. 4136), as amended, particularly by an Act approved March 10, 2012
12 (Ga. L. 2012, p. 4464), is amended by revising Section 2 to read as follows:

13 **"SECTION 2.**

14 (a) Those members of the Board of Education of Crawford County who are serving as such
15 on the effective date of this Act and any person selected to fill a vacancy in any such office

16 shall continue to serve as such members until the regular expiration of their respective terms
17 of office and upon the election and qualification of their respective successors. On and after
18 the effective date of this Act, the Board of Education of Crawford County shall consist of
19 five members all of whom shall be elected from education districts described in subsection
20 (b) of this section.

21 (b) For the purpose of electing members of the board of education, the Crawford County
22 School District shall be divided into five education districts. Districts 1, 2, 3, 4 and 5 shall
23 be and correspond to those five numbered districts described in Appendix A attached to and
24 made a part of this Act and further identified as 'User: Crawford Co. Plan Name:
25 CrawfordCCSB-2022 Plan Type: Local'.

26 (c)(1) For the purposes of such plan:

27 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
28 provided in the report of the Bureau of the Census for the United States decennial
29 census of 2020 for the State of Georgia. The separate numeric designations in a district
30 description which are underneath a VTD heading shall mean and describe individual
31 Blocks within a VTD as provided in the report of the Bureau of the Census for the
32 United States decennial census of 2020 for the State of Georgia; and

33 (B) Except as otherwise provided in the description of any district, whenever the
34 description of any district refers to a named city, it shall mean the geographical
35 boundaries of that city as shown on the census maps for the United States decennial
36 census of 2020 for the State of Georgia.

37 (2) Any part of the Crawford County School District which is not included in any district
38 described in subsection (b) of this section shall be included within that district contiguous
39 to such part which contains the least population according to the United States decennial
40 census of 2020 for the State of Georgia.

41 (3) Any part of the Crawford County School District which is described in subsection (b)
42 of this section as being included in a particular district shall nevertheless not be included

43 within such district if such part is not contiguous to such district. Such noncontiguous
44 part shall instead be included within that district contiguous to such part which contains
45 the least population according to the United States decennial census of 2020 for the State
46 of Georgia.

47 (4) Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective date of this
48 Act, shall continue to be designated as Districts 1, 2, 3, 4, and 5, respectively, but as
49 newly described under this Act, and on and after the effective date of this Act, such
50 members of the board serving from those former districts shall be deemed to be serving
51 from and representing their respective districts as newly described under this Act."

52 **SECTION 3.**

53 The provisions of this Act relating to and necessary for the regular election in 2022 of
54 members of the Board of Education of Crawford County shall become effective upon its
55 approval by the Governor or upon its becoming effective without such approval; and this Act
56 shall otherwise become effective January 1, 2023.

57 **SECTION 4.**

58 All laws and parts of laws in conflict with this Act are repealed.
