## A BILL TO BE ENTITLED AN ACT

25	(a) The salary of each associate judge shall be \$22,500.00 per annum below the salary of
26	the judges of Division 1 of the State Court of Cobb County to be paid in equal monthly
27	installments from the funds of Cobb County. The associate judges are designated as
28	full-time judges and may not engage in the private practice of law.
29	(b) The governing authority of Cobb County is authorized to pay to the Trial Judges and
30	Solicitors Retirement Fund, on behalf of the associate judges, any employee contributions
31	required for the associate judges' participation in said retirement fund. Any employee
32	contributions so paid by the governing authority of Cobb County shall be in addition to any
33	other compensation to which the associate judges are entitled."
