## A BILL TO BE ENTITLED AN ACT

- 1 To amend Chapter 6 of Title 49 of the Official Code of Georgia Annotated, relating to
- 2 services for the aging, so as create a new adult day center licensure exclusion; to authorize
- 3 the Department of Community Health to establish and implement the Georgia Program of
- 4 All-Inclusive Care for the Elderly (PACE) as part of the state's medical assistance program;
- 5 to provide for definitions; to exempt PACE organizations from the requirement to obtain a
- 6 certificate of authority as a health maintenance organization; to provide for related matters;
- 7 to repeal conflicting laws; and for other purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 SECTION 1.

- 10 Chapter 6 of Title 49 of the Official Code of Georgia Annotated, relating to services for the
- 11 aging, is amended in Article 7, relating to licensure of adult day centers, by revising
- 12 paragraph (3) of Code Section 49-6-82, relating to definitions, as follows:
- 13 "(3) 'Adult day health services' means the provision of a comprehensive plan of services
- that meets the needs of aging adults under a medical model, as defined in paragraph (6)
- of this Code section. This term shall not include programs which provide day habilitation
- and treatment services exclusively for individuals with developmental disabilities or the

18 <u>of this chapter</u>."

19 SECTION 2.

20 Said chapter is further amended by adding a new article to read as follows:

21 "ARTICLE 9

- 22 49-6-100.
- 23 The purpose of this article is to establish additional opportunities within Georgia's
- Medicaid program to provide comprehensive, integrated acute and long-term healthcare
- 25 <u>services to qualifying individuals who require skilled nursing care so that such individuals</u>
- 26 <u>can continue living in the community.</u>

- As used in this article, the term:
- 29 (1) 'Department' means the Department of Community Health.
- 30 (2) 'Georgia Program of All-Inclusive Care for the Elderly' or 'PACE' means the
- 31 comprehensive, voluntary program that provides an alternative to nursing home care for
- 32 eligible older adults as authorized by the federal government under the federal Social
- 33 Security Act, 42 U.S.C. Sections 1395eee and 1396u-4, as amended.
- 34 (3) 'Medicaid' shall have the same meaning as set forth in Code Section 49-5-272.
- 35 (4) 'Medical assistance' shall have the same meaning as set forth in Code Section
- 36 49-4-141.

- 38 (a) The department, as part of the medical assistance program in Chapter 5 of this title,
- 39 may develop and implement the Georgia Program of All-Inclusive Care for the Elderly
- 40 (PACE), pursuant to the requirements of Title XIX of the federal Social Security Act, as
- 41 <u>amended, regulations promulgated pursuant thereto by the secretary of health and human</u>
- 42 <u>services, all applicable laws of this state, the state plan, and regulations of the department</u>
- which are in effect on the date on which the items are rendered.

- 45 A PACE organization shall be exempt from the requirement, pursuant to Chapter 21 of
- 46 Title 33, to obtain a certificate of authority as a health maintenance organization."
- 47 **SECTION 3.**
- 48 All laws and parts of laws in conflict with this Act are repealed.
