

House Bill 1099 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED

AN ACT

1 To amend an Act providing the method of election of the members of the Board of Education  
2 of Laurens County, approved March 18, 1986 (Ga. L. 1986, p. 3821), as amended,  
3 particularly by an Act approved March 13, 2012 (Ga. L. 2012, p. 4286), so as to change the  
4 description of the education districts; to provide for definitions and inclusions; to provide for  
5 continuation in office of current members; to provide for election and terms of office of  
6 subsequent members; to provide for effective dates; to repeal conflicting laws; and for other  
7 purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **SECTION 1.**

10 An Act providing the method of election of the members of the Board of Education of  
11 Laurens County, approved March 18, 1986 (Ga. L. 1986, p. 3821), as amended, particularly  
12 by an Act approved March 13, 2012 (Ga. L. 2012, p. 4286), is amended by revising Section 1  
13 as follows:

## "SECTION 1.

(a) Those members of the Board of Education of Laurens County who are serving on the effective date of this Act and any person selected to fill a vacancy in any such office shall continue to serve as such members until the regular expiration of their terms of office and the election and qualification of their respective successors. On and after the effective date of this Act, the Board of Education of Laurens County shall consist of five members elected as provided in this Act. On and after the effective date of this Act, any election conducted to fill a vacancy on the Board of Education of Laurens County shall be conducted under the new rather than the former education districts.

(b) For the purpose of electing members of the board of education, the Laurens County School District is divided into five education districts, and those districts shall be and correspond to those five numbered districts described in Appendix A attached to and made a part of this Act and further identified as 'User: Laurens SB Plan Name: LaurensSB-2022 Plan Type: Local'.

(c)(1) For the purposes of such plan:

(A) The term 'VTD' shall mean and describe the same geographical boundaries as provided in the report of the Bureau of the Census for the United States decennial census of 2020 for the State of Georgia. The separate numeric designations in a district description which are underneath a VTD heading shall mean and describe individual Blocks within a VTD as provided in the report of the Bureau of the Census for the United States decennial census of 2020 for the State of Georgia; and

(B) Except as otherwise provided in the description of any district, whenever the description of any district refers to a named city, it shall mean the geographical boundaries of that city as shown on the census maps for the United States decennial census of 2020 for the State of Georgia.

(2) Any part of the Laurens County School District which is not included in any district described in subsection (b) of this section shall be included within that district contiguous

41 to such part which contains the least population according to the United States decennial  
42 census of 2020 for the State of Georgia.

43 (3) Any part of the Laurens County School District which is described in subsection (b)  
44 of this section as being included in a particular district shall nevertheless not be included  
45 within such district if such part is not contiguous to such district. Such noncontiguous  
46 part shall instead be included within that district contiguous to such part which contains  
47 the least population according to the United States decennial census of 2020 for the State  
48 of Georgia."

49 **SECTION 2.**

50 Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective date of this Act,  
51 shall continue to be designated as Districts 1, 2, 3, 4, and 5, respectively, but as newly  
52 described under this Act, and on and after the effective date of this Act, such members of the  
53 board serving from those former districts shall be deemed to be serving from and  
54 representing their respective districts as newly described under this Act.

55 **SECTION 3.**

56 The provisions of this Act necessary to conduct elections for the members of the board  
57 in 2022 shall become effective upon the approval of this Act by the Governor or upon its  
58 becoming law without such approval. The remaining provisions of this Act shall become  
59 effective on January 1, 2023.

60 **SECTION 4.**

61 All laws and parts of laws in conflict with this Act are repealed.
