A BILL TO BE ENTITLED AN ACT

To amend an Act to increase the number of commissioners of roads and revenues for the county of Calhoun from three to five, approved August 10, 1908 (Ga. L. 1908, p. 276), as amended, particularly by an Act approved February 27, 2012 (Ga. L. 2012, p. 3623), so as to change the description of the commissioner districts; to provide for definitions and inclusions; to provide for continuation in office of current members; to provide for effective dates; to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

9 An Act to increase the number of commissioners of roads and revenues for the county of
10 Calhoun from three to five, approved August 10, 1908 (Ga. L. 1908, p. 276), as amended,
11 particularly by an Act approved February 27, 2012 (Ga. L. 2012, p. 3623), is amended by
12 revising Section 1 as follows:

13 "SECTION 1.
14 (a) For purposes of electing members of the board of commissioners, Calhoun County is
15 divided into five commissioner districts. One member of the board shall be elected from

each such district. Such districts shall be and correspond to those five numbered districts
described in Appendix A attached to and made a part of this Act and further identified as
'User: Calhoun Co. Plan Name: CalhounCCSB-2022 Plan Type: Local'.

19 (b)(1) For the purposes of such plan:

(A) The term 'VTD' shall mean and describe the same geographical boundaries as
provided in the report of the Bureau of the Census for the United States decennial
census of 2020 for the State of Georgia. The separate numeric designations in a district
description which are underneath a VTD heading shall mean and describe individual
Blocks within a VTD as provided in the report of the Bureau of the Census for the
United States decennial census of 2020 for the State of Georgia; and

- (B) Except as otherwise provided in the description of any district, whenever the
 description of any district refers to a named city, it shall mean the geographical
 boundaries of that city as shown on the census maps for the United States decennial
 census of 2020 for the State of Georgia.
- 30 (2) Any part of Calhoun County which is not included in any commissioner district
 31 described in subsection (a) of this section shall be included within that particular
 32 commissioner district contiguous to such part which contains the least population
 33 according to the United States decennial census of 2020 for the State of Georgia.
- 34 (3) Any part of Calhoun County which is described in subsection (a) of this section as
 35 being included in a particular commissioner district shall nevertheless not be included
 36 within such district if such part is not contiguous to such commissioner district. Such
 37 noncontiguous part shall instead be included within that particular commissioner district
 38 contiguous to such part which contains the least population according to the United States
 39 decennial census of 2020 for the State of Georgia."

SECTION 2.

(a) Those members of the board of commissioners of Calhoun County who are serving as
such on the effective date of this Act and any person selected to fill a vacancy in any such
office shall continue to serve as such members until the regular expiration of their respective
terms of office and upon the election and qualification of their respective successors.

(b) Commissioner Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective
date of this Act, shall continue to be designated as Commissioner Districts 1, 2, 3, 4, and 5,
respectively, but as newly described under this Act, and on and after the effective date of this
Act, such members of the board serving from those former commissioner districts shall be
deemed to be serving from and representing their respective districts as newly described
under this Act.

SECTION 3.

52 The provisions of this Act necessary to conduct elections for the members of the board of 53 commissioners of Calhoun County in 2022 shall become effective upon the approval of this 54 Act by the Governor or upon its becoming law without such approval. The remaining 55 provisions of this Act shall become effective on January 1, 2023.

SECTION 4.

57 All laws and parts of laws in conflict with this Act are repealed.
