1 To amend Code Section 40-2-86 of the Official Code of Georgia Annotated, relating to 2 special license plates promoting or supporting certain worthy agencies, funds, or nonprofit 3 corporations with proceeds disbursed to the general fund and the agency, fund, or nonprofit 4 corporation, so as to establish a specialty license plate honoring the Shepherd Center; to provide for disposition of funds to the Shepherd Center; to establish a specialty license plate supporting the advocacy and promotion of strict interpretation of the United States 7 Constitution with a portion of funds collected to be disbursed to the Foundation for Moral 8 Law, Inc.; to establish a specialty license plate honoring the Okefenokee Swamp; to provide 9 for the disposition of funds to the Okefenokee Swamp Park; to establish a specialty license 10 plate honoring alumni of Samford University; to provide for disposition of funds to the Samford University Alumni Association; to amend Code Section 40-2-86.1 of the Official 12 Code of Georgia Annotated, relating to special license plates promoting or supporting certain 13 worthy agencies, funds, or nonprofit corporations and qualified motor vehicles or drivers 14 with proceeds deposited into the general fund, so as to establish an "America First" specialty 15 license plate; to provide for conditions for the production of such license plates; to provide 16 for discontinuing the manufacture of such license plates in certain instances; to provide for 17 the disposition of funds to the general fund; to provide for related matters; to provide for an

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

21	SECTION 1.
22	Code Section 40-2-86 of the Official Code of Georgia Annotated, relating to special license
23	plates promoting or supporting certain worthy agencies, funds, or nonprofit corporations with
24	proceeds disbursed to the general fund and the agency, fund, or nonprofit corporation, is
25	amended in subsection (l) by adding new paragraphs to read as follows:
26	"(71) A special license plate honoring the Shepherd Center. The funds raised by the sale
27	of this special license plate shall be disbursed to Shepherd Center, Inc.
28	(72) A special license plate supporting the advocacy and promotion of strict
29	interpretation of the United States Constitution. The funds raised by the sale of this
30	special license plate shall be disbursed to the Foundation for Moral Law, Inc.
31	(73) A special license plate honoring the Okefenokee Swamp and displaying the words
32	'Explore the Okefenokee.' The funds raised by the sale of this special license plate shall
33	be disbursed to the Okefenokee Swamp Park.
34	(74) A special license plate honoring alumni of Samford University. The funds raised
35	by the sale of this special license plate shall be disbursed to the Samford University
36	Alumni Association."

SECTION 2.

38 Code Section 40-2-86.1 of the Official Code of Georgia Annotated, relating to special license

39 plates promoting or supporting certain worthy agencies, funds, or nonprofit corporations and

40 qualified motor vehicles or drivers with proceeds deposited into the general fund, is amended

41 in subsection (l) by adding a new paragraph to read as follows:

42 "(12) A special license plate displaying an image of the American flag, and the words 'America First' to represent patriotism and a commitment to prioritize the interests of this 43 nation above all else and to reinforce a sense of national pride and unity. 44 Notwithstanding subsection (h) of this Code section, the department shall be authorized 45 46 to issue such license plate prior to receipt of 1,000 prepaid applications; provided, 47 however, that, if 1,000 applications have not been submitted prior to January 1, 2027, the department shall not continue to manufacture such plate. The funds raised by the sale of 48 49 this special license plate shall be deposited in the general fund."

SECTION 3.

51 This Act shall become effective on January 1, 2025.

SECTION 4.

- 53 In accordance with the requirements of Article III, Section IX, Paragraph VI(n) of the
- 54 Constitution of the State of Georgia, this Act shall not become law unless it receives the
- 55 requisite two-thirds' majority vote in both the Senate and the House of Representatives.

56 SECTION 5.

57 All laws and parts of laws in conflict with this Act are repealed.
