A BILL TO BE ENTITLED
AN ACT

1 To amend Title 43 of the Official Code of Georgia Annotated, relating to professions and
2 businesses, so as to update and revise various provisions relating to occupational therapists;
3 to revise the short title; to revise the declaration of purpose; to revise definitions; to include
4 telehealth in the practice of occupational therapy; to revise provisions relating to the
5 membership, powers, and duties of the State Board of Occupational Therapy; to revise
6 provisions relating to the division director; to provide an additional subject of training to
7 utilize physical agent modalities; to revise provisions relating to qualifications of applicants
8 for licensure; to authorize the board to require additional competency in certain
9 circumstances; to revise provisions relating to use of titles and abbreviations; to revise the
10 meaning of unprofessional conduct; to provide for statutory construction; to provide for
11 related matters; to repeal conflicting laws; and for other purposes.

12 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

14 Title 43 of the Official Code of Georgia Annotated, relating to professions and businesses,
15 is amended by revising Chapter 28, relating to occupational therapists, as follows:

17 43-28-1.

18 This chapter shall be known and may be cited as the 'Georgia ~~State~~ Occupational Therapy
19 ~~Licensing Practice~~ Act.'

20 43-28-2.

21 This chapter was enacted to safeguard the public health, safety, and welfare and to assure
22 the availability of occupational therapy services of high quality to persons in need of such
23 services. It is the purpose of this chapter to provide for the regulation of persons offering

24 ~~occupational therapy services to the public representing themselves as occupational~~
 25 ~~therapists or as occupational therapy assistants, or persons performing services that~~
 26 ~~constitute occupational therapy.~~

27 43-28-3.

28 As used in this chapter, the term:

29 ~~(1) 'Association' means the Georgia Occupational Therapy Association.~~

30 ~~(2)~~(1) 'Board' means the State Board of Occupational Therapy.

31 ~~(3)~~(2) 'License' means a valid and current certificate of registration issued by the division
 32 director.

33 (3) 'National Board for Certification in Occupational Therapy (NBCOT)' means a
 34 national organization that administers a national certification examination for
 35 occupational therapists and occupational therapy assistants.

36 (4) 'Occupations' means activities of daily living in which people engage.

37 ~~(4)~~(5) 'Occupational therapist' means a person licensed to practice occupational therapy
 38 as defined in this chapter and whose license is in good standing.

39 ~~(5)~~(6) 'Occupational therapy' means the therapeutic use of occupations with individuals,
 40 groups, populations, or organizations to support participation, performance, and function
 41 in life roles. Occupational therapy is provided for habilitation, rehabilitation, and the
 42 promotion of health and wellness to those who have or are at risk for developing activity
 43 limitation or participation restriction. Occupational therapy addresses the physical,
 44 cognitive, psychosocial, sensory-perceptual, and other aspects of performance in a variety
 45 of contexts and environments to support engagement in occupations promoting health,
 46 well-being, and quality of life. The practice of occupational therapy, including that which
 47 may be provided through telehealth, includes, but is not limited to, the following:

48 (A) Evaluation, treatment, education of, and consultation with, individuals, groups, and
 49 populations whose abilities to participate safely in occupations, including activities of
 50 daily living (ADL), instrumental activities of daily living (IADL), rest and sleep,
 51 education, work, play, leisure, and social participation, are impaired or at risk for
 52 impairment due to issues related, but not limited to, developmental deficiencies, the
 53 aging process, learning disabilities, physical environment and sociocultural context,
 54 physical injury or disease, cognitive impairments, and psychological and social
 55 disabilities;

56 (B) Evaluation to determine abilities and limitations related to performance of
 57 occupations, including the identification of physical, sensory, cognitive, emotional, or
 58 social deficiencies. Treatment based on such evaluation utilizes task oriented,
 59 purposeful, and meaningful goal directed activities to prevent, correct, minimize, or

60 compensate for deficiencies to maximize independence in daily life and promote overall
 61 health and wellbeing; and

62 (C) Specific occupational therapy techniques used for treatment that involve, but are
 63 not limited to, training in activities of daily living; environmental modification; the
 64 designing, fabrication, and application of orthotic or orthotic devices; selecting,
 65 applying, and training in the use of assistive technology and adaptive devices; sensory,
 66 motor, and cognitive activities; therapeutic exercises; manual therapy techniques that
 67 do not include adjustment or manipulation of the articulations of the human body; and
 68 physical agent modalities. Such techniques are applied in the treatment of individuals,
 69 groups, or through organizational-level practices to enhance physical functional
 70 performance, work capacities, and community participation.

71 includes but is not limited to the following:

72 ~~(A) Evaluation and treatment of individuals whose abilities to cope with the tasks of~~
 73 ~~living are threatened or impaired by developmental deficiencies, the aging process,~~
 74 ~~learning disabilities, poverty and cultural differences, physical injury or disease,~~
 75 ~~psychological and social disabilities, or anticipated dysfunction. The treatment~~
 76 ~~utilizes task oriented activities to prevent or correct physical, cognitive, or emotional~~
 77 ~~deficiencies or to minimize the disabling effect of these deficiencies in the life of the~~

79 ~~(B) Such evaluation techniques as assessment of sensory motor abilities, assessment~~
 80 ~~of the development of self-care activities and capacity for independence, assessment~~
 81 ~~of the physical capacity for prevocational and work tasks, assessment of play and~~
 82 ~~leisure performance, and appraisal of living areas for persons with disabilities; and~~

83 ~~(C) Specific occupational therapy techniques, such as activity analysis, activities of~~
 84 ~~daily living skills, the fabrication and application of splints and adaptive devices,~~
 85 ~~sensory motor activities, the use of specifically designed manual and creative~~
 86 ~~activities, guidance in the selection and use of adaptive equipment, specific exercises~~
 87 ~~and physical agent modalities to enhance physical functional performance, work~~
 88 ~~capacities, and treatment techniques for physical capabilities and cognitive retraining.~~
 89 ~~Such techniques are applied in the treatment of individual patients or clients, in~~
 90 ~~groups, or through social systems:~~

91 ~~(6)(7)~~ 'Occupational therapy aide' means a an unlicensed person who assists provides
 92 supportive services to the occupational therapist and the occupational therapy assistant
 93 in the practice of occupational therapy and who works under the direct supervision of the
 94 occupational therapist or the occupational therapist assistant.

95 ~~(7)~~(8) 'Occupational therapy assistant' means a person licensed to assist the occupational
 96 therapist in the practice of occupational therapy under the supervision of or with the
 97 consultation of the licensed occupational therapist and whose license is in good standing.

98 (9) 'Occupational therapy practitioner' means a licensed occupational therapist or
 99 licensed occupational therapy assistant.

100 (10) 'Orthotic' or 'orthotic device' means a rigid or semi-rigid device or splint used to
 101 support a weak or deformed body part. An orthotic may be used to restrict, eliminate, or
 102 enhance motion; to support a healing body part; or to substitute for lost function or
 103 motion and can be custom fabricated, custom fitted, or prefabricated.

104 ~~(8)~~(11) 'Person' means a natural person only, not a legal entity.

105 ~~(9)~~(12) 'Physical agent modalities' means occupational therapy treatment techniques,
 106 both superficial and deep tissue, which may, but are not required to utilize the following
 107 agents: heat, light, sound, cold, electricity, or thermal, mechanical, electromagnetic,
 108 water, and light for a specific therapeutic effect to promote functional outcomes. devices
 109 and also means electrical therapeutic modalities which induce heat or electrical current
 110 beneath the skin, including but not limited to therapeutic ultrasound, galvanism,
 111 microwave, diathermy, and electromuscular stimulation, and also means hydrotherapy.

112 (13) 'Telehealth' means the application of evaluative, consultative, preventative, and
 113 therapeutic services delivered through telecommunication and information technologies
 114 by licensed occupational therapy practitioners. This may include, but shall not be limited
 115 to, telemedicine, telepractice, telecare, telerehabilitation, and e-health services.

117 (a) There is established the State Board of Occupational Therapy.

118 (b) The board shall consist of six members who shall each be appointed by the Governor
 119 and confirmed by the Senate for a term of four years and until a successor is appointed and
 120 qualified.

121 (c) The members of the board shall be citizens of the United States and residents of this
 122 state for at least one year prior to their appointment.

123 ~~(d)~~(1) Five members of the board shall have been engaged in rendering services to the
 124 public, teaching, or research in occupational therapy for at least three years immediately
 125 preceding their appointment and may be occupational therapists or occupational therapy
 126 assistants and shall at all times be holders of valid licenses for the practice of
 127 occupational therapy in this state. All of such members shall fulfill the requirements for
 128 licensure of this chapter.

129 (2) The sixth member shall be appointed from the public at large and shall have no
 130 connection whatsoever with the profession or practice of occupational therapy.

131 ~~(c) The board shall, within 90 days after July 1, 1976, be selected as provided in~~
 132 ~~subsection (b) of this Code section. The members of the first board shall serve the~~
 133 ~~following terms: two members for a term of one year, two members for a term of two~~
 134 ~~years, and one member for a term of three years.~~

135 ~~(e) At the expiration of the above terms, board members~~ a term, a board member shall be
 136 appointed in the same manner as the initial appointment ~~for a period of four years;~~ but no
 137 person shall be appointed to serve more than two consecutive terms. Terms shall begin on
 138 the first day of the calendar year and end on the last day of the calendar year or until
 139 successors are appointed, ~~except for the first members who shall serve through the last~~
 140 ~~calendar day of the year in which they are appointed before commencing the terms~~

142 ~~(d) The initial term of the member appointed from the public at large shall expire on June~~

144 ~~(e)~~(f) When a vacancy occurs on the board, the Governor shall appoint a member to fill
 145 the unexpired term.

146 ~~(f)~~(g) The Governor, after notice and opportunity for hearing by the board, may remove
 147 any member of the board for neglect of duty, incompetence, revocation or suspension of
 148 his or her license, or other dishonorable conduct. After such removal or vacancy due to
 149 other reasons, the Governor shall appoint a successor to the unexpired term.

151 (a) The division director shall be secretary of the board and in addition to his or her powers
 152 and duties prescribed by Chapter 1 of this title shall perform such other administrative
 153 duties as may be prescribed by the board.

154 (b) In a contested case, the division director on behalf of the board shall have the power

168 (a) The board shall administer, coordinate, and enforce this chapter.

169 (b) The board shall adopt rules and regulations to carry out the policy of this chapter,
 170 including, but not limited to, rules and regulations relating to professional licensure and the
 171 establishment of ethical standards of practice.

172 (c) The board shall have the responsibility of evaluating and determining the qualifications
 173 and providing for the examination of occupational therapist and occupational therapy
 174 assistant applicants for licensure under this chapter and shall assist the division director in
 175 carrying out this chapter.

176 (d) In a timely manner, the board shall:

177 (1) Authorize the issuance and renewal of licenses to qualified occupational therapists
 178 and occupational therapy assistants;

179 (2) Discipline and sanction licensees, including the suspension and revocation of
 180 licenses; and

181 (3) Approve qualified occupational therapy schools and academic programs in
 182 occupational therapy for the purpose of licensing applicants.

183 (e) The division director shall have the authority to contract with an outside agency for
 184 services providing for the supervision and administration of the examination as needed.

185 ~~(e)~~(f) The board may initiate investigations, issue subpoenas, examine witnesses, and
 186 administer oaths and may investigate allegations of practices violating this chapter and
 187 board rules. For purposes of this subsection, an authorized agent of the board shall have
 188 the power and right to enter and make reasonable inspection of any place where
 189 occupational therapy is practiced.

190 ~~(d) The board shall adopt rules and regulations relating to professional conduct to carry~~
 191 ~~out the policy of this chapter, including, but not limited to, regulations relating to~~
 192 ~~professional licensure and the establishment of ethical standards of practice for persons~~
 193 ~~holding a license to practice occupational therapy in this state and may amend or repeal the~~
 194 ~~same in accordance with Chapter 13 of Title 50, the 'Georgia Administrative Procedure~~
 195 ~~Act.'~~

196 ~~(e) The board shall conduct such hearings and keep such records and minutes as are~~
 197 ~~necessary to carry out its functioning. It shall provide reasonable public notice to the~~
 198 ~~appropriate persons of the time and place of all hearings authorized under this chapter in~~
 199 ~~such a manner and at such times as it may determine by its rules and regulations.~~

200 ~~(f) The board shall prepare or approve all examinations of applicants for license at least~~
 201 ~~twice a year, determine the qualifications and authorize the issuance of licenses to qualified~~
 202 ~~occupational therapists and occupational therapy assistants, issue and renew licenses,~~
 203 ~~suspend or revoke licenses in the manner provided, and determine the qualifications and~~
 204 ~~approved qualified occupational therapy schools and courses in occupational therapy for~~

 207 to this chapter by appropriate regulation.

 223 approved by the board which covers the following subjects:

226 (B) Physiological, neurophysiological, and electrophysiological, as indicated, changes
 227 which occur as a result of the application of the selected modality;

228 (C) The response of normal and abnormal tissue to the application of the modality;

231 (E) Guidelines for treatment or administration of the modality within the philosophical
 232 framework of occupational therapy;

233 (F) Appropriate selection and practical application of physical agent modalities,
 234 including determining treatment parameters based on existing pathology, impairments,
 235 functional limitations, and expected outcomes;

236 ~~(F)~~(G) Guidelines for educating the patient, including instructing the patient as to the
 237 process and possible outcomes of treatment, including risks and benefits;

238 ~~(G)~~(H) Safety rules and precautions related to the selected modality;

239 ~~(H)~~(I) Methods for documenting the effectiveness of immediate and long-term effects
 240 of treatment; and

241 ~~(I)~~(J) Characteristics of the equipment, including safe operation, adjustment, and care
 242 of the equipment.

243 (b) The board shall promulgate rules and regulations specifically pertaining to the use of
 244 physical agent modalities by a person licensed under this chapter.

246 (a) An applicant applying for a license as an occupational therapist or as an occupational
 247 therapy assistant shall file an application, on forms provided by the board, showing to the
 248 satisfaction of the board that such applicant:

249 (1) Is of good moral character;

250 (2) Has successfully completed the academic requirements of an accredited educational
 251 program in occupational therapy recognized by the board, with concentration in
 252 biological or physical science, psychology, and sociology and with education in selected
 253 manual skills. For an occupational therapist or occupational therapy assistant, such a
 254 program shall be accredited by a recognized accrediting agency acceptable to the board.
 255 Other comparable educational programs such as those approved by the World Federation
 256 of Occupational Therapists may be recognized by the board upon evaluation of detailed
 257 program and course content. An applicant who is foreign trained shall complete an
 258 academic program that is recognized or approved by the World Federation of
 259 Occupational Therapists or such other credentialing entity recognized by the board;

260 (3) Has successfully completed a period of supervised field work experience ~~at a~~
 261 ~~recognized educational institution or a training program accredited as provided in~~
 262 ~~paragraph (2) of this subsection. For an occupational therapist, a minimum of six months~~
 263 ~~of supervised field work experience is required. For an occupational therapy assistant,~~
 264 ~~a minimum of two months of supervised field work experience is required~~ approved by
 265 the board; and

266 (4) Has passed an examination approved by the board as provided for in Code Section
 267 43-28-10.

268 (b) An applicant not meeting the requirements of subsection (a) of this Code section must
 269 indicate to the board that he or she has obtained a waiver of such requirements pursuant to
 270 Code Section 43-28-11.

272 (a) A person applying for licensure shall demonstrate his or her eligibility in accordance
 273 with the requirements of Code Section 43-28-9 and shall make application for examination
 274 upon a form and in such a manner as the board shall prescribe. Such application shall be
 275 accompanied by the fee prescribed by the board. ~~A person who fails an examination may
 276 make reapplication for reexamination accompanied by the prescribed fee.~~

287 ~~(d) Applicants may obtain their examination scores and may review their papers in~~
 288 ~~accordance with such rules and regulations as the board may establish.~~

289 (c) Applicants who fail the examination may retake the examination; provided, however,
 290 that prior to the issuance of a license, the board may require reexamination applicants to
 291 demonstrate competency in a manner deemed appropriate by the board if:

292 (1) The applicant has failed the examination three times or more; or

293 (2) The applicant has failed to pass the examination within five years of completion of
 294 the academic requirements for licensure as set out in paragraph (2) of subsection (a) of
 295 Code Section 43-28-9.

297 The board may waive the examination and grant a license to any applicant who shall
 298 present proof of current licensure as an occupational therapist or an occupational therapy
 299 assistant in another state, the District of Columbia, or territory of the United States, which
 300 requires standards for licensure considered by the board to be equivalent to the
 301 requirements for licensure of this chapter.

318 an occupational therapist who holds a current license in this state.

324 (d)(1) A licensed occupational therapist may use the words 'occupational therapist' or

326 designation, including 'O.T.' and 'O.T./L.', that identifies such person as a licensed
327 occupational therapist, in connection with the name or place of business, and any activity,
328 practice, or service, so long as the licensee is at all times in compliance with the

349 (a) ~~The~~ In addition to the powers granted in Code Section 43-1-19, the board shall, after
 350 notice and opportunity for hearing, have the power to deny or refuse to renew, suspend, or
 351 revoke the license of, or impose a fine or probationary conditions upon, any licensee who
 352 has been ~~guilty of~~ engaged in unprofessional conduct which has endangered or is likely to
 353 endanger the health, welfare, or safety of the public. ~~Such unprofessional~~ Unprofessional
 354 conduct, as defined by the rules and regulations of the board, includes, but is not limited
 355 to:

356 (1) Obtaining or attempting to obtain a license by fraud, misrepresentation, or
 357 concealment of material facts;

358 ~~(2) Being guilty of unprofessional conduct as defined by the rules and regulations~~

 369 occupational therapy aide in accordance with this chapter and board rules;

370 (6) Knowingly delegating responsibilities to an individual who does not have the
 371 knowledge, skills, or abilities to perform those responsibilities;

372 (7) Practicing as an occupational therapist or occupational therapy assistant when
 373 physically or mentally impaired;

374 (8) Having had an occupational therapist or occupational therapy assistant license

391 ~~(3)(12) Being convicted of a crime other than minor offenses defined as 'minor~~
 392 ~~misdemeanors,' 'violations,' or 'offenses' in any court if the acts for which he was~~
 393 ~~convicted are found by the board to have~~ that has a direct bearing on whether ~~he~~ the
 394 licensee should be entrusted to serve the public in the capacity of an occupational

396 (b) Such denial, refusal to renew, suspension, revocation, or imposition of a fine or
 397 probationary conditions upon a licensee may be ordered by the board in a decision made

 399 and in accordance with Chapter 13 of Title 50, the 'Georgia Administrative Procedure Act.'

405 (a) All licenses shall expire biennially. Each person licensed under this chapter is
 406 responsible for renewing his or her license before the expiration date. Application for
 407 renewal shall be completed in the manner prescribed in the rules and regulations of the
 408 division director and shall include the payment of a renewal fee. The board may set and
 409 require a specific number of continuing education hours for license renewal.

410 (b) The board may provide for late renewal of a license upon payment of a late renewal
411 fee, proof of continuing education as set by the board, and completion of an appropriate
412 form. Any license which is not renewed during the specified renewal period will be
413 revoked for failure to renew. The holder of such a canceled license may apply for and
414 obtain a valid license only upon compliance with all relevant requirements for

416 (c) A suspended license is subject to expiration and may be renewed as provided in this

423 Nothing in this chapter shall be construed as preventing or restricting the practice, services,
424 or activities of:

425 (1) Any person licensed under any other law of the state, including but not limited to,
426 physicians; and persons working under the supervision of physicians, nurses, clinical
427 psychologists, speech pathologists and audiologists, dentists, chiropractors, and physical
428 therapists, from engaging in the profession or occupation for which he or she is licensed;

442 educational program sponsored by an educational institution approved by the board and

461 (a) Any person who violates this chapter shall be guilty of a misdemeanor and, upon
 462 conviction thereof, shall be punished by a fine of not less than \$250.00 and not more than

 464 by any person convicted under this Code section shall be forfeited and revoked

 475 directly or by implication, or to represent himself or herself as an occupational therapist or
 476 an occupational therapy assistant."
