## A BILL TO BE ENTITLED AN ACT

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 **SECTION 1.** 7 An Act creating a new charter for the City of Kennesaw, approved May 6, 2013 (Ga. L. 8 2013, p. 4234), as amended, particularly by an Act approved April 10, 2014 (Ga. L. 2014, 9 p. 4106), is amended by adding at the end of Section 1.02 the following: 10 "(c) The corporate limits of the City of Kennesaw shall also include the following 11 described parcels of land: 12 Tract 1. All that tract or parcel of land lying and being in Land Lots 207, 208, 211 and 212 of the 13 14 20th District, 2nd Section, Cobb County, Georgia, and being more particularly described 15 as follows: BEGINNING at a 5/8-inch rebar set at the intersection of the Southwesterly right-of-way 16 17 line of U.S. Highway 41, a.k.a.
