A BILL TO BE ENTITLED AN ACT

- 1 To amend Part 7 of Article 7 of Chapter 3 of Title 20 of the Official Code of Georgia
- 2 Annotated, relating to HOPE scholarships and grants, so as to establish the HOPE
- 3 tuition-free grant; to provide for eligibility requirements; to provide for the amount of the
- 4 grant; to provide for limitations; to provide for related matters; to repeal conflicting laws; and
- 5 for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.

- 8 Part 7 of Article 7 of Chapter 3 of Title 20 of the Official Code of Georgia Annotated,
- 9 relating to HOPE scholarships and grants, is amended by revising Code Section 20-3-519.7,
- 10 which is reserved, to read as follows:
- 11 "20-3-519.7.
- 12 (a) To be eligible for a HOPE tuition-free grant, a student seeking a certificate or diploma
- at a branch of the Technical College System of Georgia shall, in addition to meeting the
- residency requirements set forth in subsection (a) of Code Section 20-3-519.1:
- 15 (1) Be enrolled in a program of study leading to a certificate or diploma in a field
- designated by the State Board of the Technical College System of Georgia to be in high
- 17 <u>demand in Georgia; and</u>
- 18 (2) Meet enrollment standards by being admitted, enrolled, and classified as an
- 19 <u>undergraduate student in a matriculated status and maintaining satisfactory academic</u>
- 20 progress in accordance with the standards and practices used for federal Title IV
- 21 programs by the institution at which the student is enrolled.
- 22 (b) Subject to the provisions of subsection (d) of this Code section, an eligible student may
- 23 receive HOPE tuition-free grants for all coursework required by the institution for
- 24 programs of study leading to a certificate or diploma.
- 25 (c) Subject to the amounts appropriated by the General Assembly and provisions relating
- 26 <u>to the Lottery for Education Account in Code Section 50-27-13, a HOPE tuition-free grant</u>

21	awarded under this Code section shall equal the tuition and fees at the postsecondary
28	<u>institution.</u>
29	(d) No student who has a baccalaureate degree, its equivalent or higher, from any
30	postsecondary institution shall be eligible to receive a HOPE tuition-free grant. No student
31	may receive cumulative HOPE and HOPE tuition-free grants for more than 95 quarter
32	hours or 63 semester hours of attempted coursework. No student may receive more than
33	a cumulative total of 190 quarter hours or 127 semester hours of combined HOPE
34	scholarships and grants. Reserved."
