A BILL TO BE ENTITLED AN ACT

1 To amend Chapter 12 of Title 50 of the Official Code of Georgia Annotated, relating to 2 commissions and other agencies, so as to provide for the creation of the Georgia Endowment 3 for Teaching Professionals to foster a public-private partnership for support of postsecondary 4 teaching professionals in high demand courses, subjects, and disciplines; to provide for a 5 board of trustees; to provide for the membership, appointment, terms, and filling of vacancies of the board of trustees; to provide for the creation, appointment, terms, filling of vacancies, 6 7 duties, and responsibilities of an advisory committee to the board of trustees; to provide for 8 the purposes of the endowment; to provide for the duties and responsibilities of the board of 9 trustees; to provide for discontinuation of the endowment under certain circumstances; to 10 provide for certain reports and audits; to provide for related matters; to repeal conflicting 11 laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

14 Chapter 12 of Title 50 of the Official Code of Georgia Annotated, relating to commissions

and other agencies, is amended by revising Article 7, which is reserved, to read as follows:

"ARTICLE 7 16

17	<u>50-12-110.</u>
18	(a) In order to foster a public-private partnership for the support of postsecondary teaching
19	professionals in high demand courses, subjects, and disciplines, there is created the Georgia
20	Endowment for Teaching Professionals. Such endowment shall be for the purpose of
21	receiving and distributing funds for the support of a program of endowments within the
22	Technical College System of Georgia to support outstanding teaching professionals in high
23	demand courses, subjects, and disciplines in order to improve education and provide for
24	economic development. The Georgia Endowment for Teaching Professionals shall not be
25	an entity or agency of government, but shall be a private entity operating under and in
26	accordance with the laws of this state. It is the intent of the General Assembly that such
27	private entity take all necessary steps to become a Section 501(c)(3) entity under the
28	Internal Revenue Code.
29	(b)(1) The Georgia Endowment for Teaching Professionals shall be governed by a board
30	of trustees consisting of 11 members. The members of the board of trustees shall include
31	five members appointed by the Governor, including the commissioner of the Technical
32	College System of Georgia and the commissioner of economic development; three
33	members appointed by the President of the Senate; and three members appointed by
34	Speaker of the House of Representatives.
35	(2) The Governor shall appoint one member to serve as chairperson of the board of
36	trustees. The board of trustees may elect such other officers as it deems appropriate. The
37	board of trustees shall meet at the call of the chairperson or the request of any three
38	members.
39	(c) The members of the board of trustees shall serve terms of four years and until their
40	successors are appointed and qualified; provided, however, that the initial terms of the three
41	members appointed by the Governor other than the commissioner of the Technical College

42 System of Georgia and the commissioner of economic development shall be for two years 43 and until their successors are appointed and qualified. Thereafter, such members shall 44 serve four-year terms and until their successors are appointed and qualified. The members 45 of the board of trustees shall serve without compensation but may be reimbursed for actual 46 and reasonable expenses incurred while on the business of the endowment. 47 (d) The board of trustees shall appoint an advisory committee to assist the board members in their duties. Such advisory committee shall consist of not more than 30 members and 48 49 shall be chaired by the executive director of the endowment. The advisory committee shall 50 include at least two representatives from each of the state's congressional districts. In 51 making its appointments, the board of trustees shall select members of the various boards 52 of directors or trustees of postsecondary institutions, local business or industry associations, and economic development organizations; persons who have shown a commitment to 53 54 education and workforce development in their communities; and persons who understand 55 the needs of business and education. The members of the advisory committee shall serve 56 for four-year terms and until their successors are selected and qualified; provided, however, 57 that the board of trustees shall designate 15 of the initial appointees to serve terms of two 58 years and until their successors are selected and qualified. Such 15 members shall 59 thereafter serve four-year terms and until their successors are selected and qualified. The 60 members of the advisory committee shall serve without compensation but may be 61 reimbursed for actual and reasonable expenses incurred while on the business of the 62 advisory committee.

- The Georgia Endowment for Teaching Professionals shall have the following purposes:
- 65 (1) To support through education the efforts of the Georgia Department of Economic
- 66 Development;

67 (2) To support the improvement of public postsecondary education in Georgia through

- 68 <u>the identification of key courses, subjects, and disciplines in demand for the development</u>
- of business and industry in this state;
- 70 (3) To provide annually to individual units of the Technical College System of Georgia
- grants in an amount and for a period of time to be determined by the board of trustees on
- 72 <u>a case-by-case basis to enable a teaching professional at such unit in one or more of the</u>
- key courses, subjects, or disciplines identified, based on competitive evaluation by the
- advisory committee or subcommittee of the various proposals;
- 75 (4) To receive, invest, and administer funds received, including without limitation funds
- from the state, private donations, grants, and other sources to fulfill the purposes for
- which the endowment is created;
- 78 (5) To attract contributions and grants for the purposes of the endowment;
- 79 (6) To utilize funds of the endowment for matching dollars for foundation grants to
- 80 <u>fulfill the purposes of the endowment; and</u>
- 81 (7) To engage in other activities designed to support Georgia's postsecondary education
- systems' contribution to economic development and tourism.

- The board of trustees shall have the following duties and responsibilities:
- 85 (1) To operate and manage the Georgia Endowment for Teaching Professionals,
- 86 <u>including the investment and reinvestment of the endowment's funds, the management</u>
- of assets of the endowment, and the distribution of such funds and assets to fulfill the
- purpose of the endowment;
- 89 (2) To enter into contracts with public and private entities for services needed by the
- 90 <u>endowment and to fulfill the purposes of the endowment;</u>
- 91 (3) To employ such staff and consultants as deemed necessary to fulfill the purposes of
- 92 <u>the endowment and to manage, invest, and administer funds and assets of the endowment;</u>

93 (4) To receive, retain, and invest donations, state funding, grants, and other funds and 94 assets; provided, however, that state funding and grants may not be expended for the 95 purposes of paragraph (3) of Code Section 50-12-111 but may be expended for all other 96 purposes of the endowment; 97 (5) To ensure that an annual independent audit is conducted of all funds and assets of the 98 endowment; 99 (6) To apply for and administer grants from public and private entities to fulfill the purposes of the endowment, to assist branches of the Technical College System of 100 101 Georgia in obtaining and administering grants for these purposes, and to partner with 102 other organizations in order to obtain such grants; 103 (7) To institute and administer grant programs to fulfill the purposes of the endowment; (8) To ensure that determinations of any public funding recipients shall be based not on 104 105 political expediency but rather on the project's contribution to the general welfare of its 106 intended audience and the project's demonstration of its relative ability to provide benefits 107 to this state and its citizens as quantified as required by paragraph (10) of this Code 108 section; 109 (9) To promote, fund, conduct, and assist in the development, provision, and expansion 110 of educational courses, subjects, and disciplines identified by the board of trustees as in 111 demand for the purpose of promoting the economic development of this state; 112 (10) To develop a measurement consistent with state or national standards that will 113 ensure that information provided by the endowment in any report to the Governor and the 114 General Assembly concerning the impact of the endowment on education and economic 115 development have verifiable metrics in order to aid the General Assembly in determining 116 whether any public money expended in support of the endowment provides quantifiable 117 benefits to this state and its citizens; and 118 (11) To perform such other tasks as may be appropriate to fulfill its purposes not 119 inconsistent with law.

121 (a) No funds shall be expended by the board of trustees under the provisions of paragraphs 122 (7) and (9) of Code Section 50-12-112 until contributions to the endowment from private 123 donors aggregate \$50,000.00 and funding and grants from public sources aggregate 124 \$50,000.00. In the event that contributions to the endowment do not meet the minimum 125 requirements of this subsection by December 31, 2025, then the endowment shall be discontinued effective July 1, 2026. In such event, during the period from January 1, 2026 126 127 to June 30, 2026, the endowment shall take all reasonable and necessary steps to wind up its affairs and to return any contributions to the donors thereof, public or private. In the 128 129 event that any contribution cannot be returned to the donor on or before June 30, 2026, the 130 same shall escheat to the state on July 1, 2026. 131 (b) The funds and assets of the endowment shall be independently audited annually, and 132 the results of such audit shall be open to inspection at reasonable times by any person. A 133 copy of the audit report shall be sent to the state auditor and the state accounting officer. 134 (c) The board of trustees shall provide the Governor and the members of the General 135 Assembly with a full report of its activities and funds distribution in December of each year 136 with recommendations, if any, for legislation to assist the endowment in achieving its 137 purposes. The report shall include information on the impact of the endowment on 138 education and economic development, specifying the metric results using the measurement 139 system developed by the endowment as required in paragraph (10) of Code Section 140 50-12-112."
