A BILL TO BE ENTITLED AN ACT

To amend Code Section 16-13-30 of the Official Code of Georgia Annotated, relating to purchase, possession, manufacture, distribution, or sale of controlled substances or marijuana and penalties, so as to codify the proclamation by the Office of the President of the United States, that would grant a pardon and restore full political, civil, and other rights regarding the offense of simple possession of marijuana; to provide for limitations; to provide for related matters; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

9 Code Section 16-13-30 of the Official Code of Georgia Annotated, relating to purchase,

possession, manufacture, distribution, or sale of controlled substances or marijuana and
penalties, is amended by adding a new subsection to read as follows:

12 "(j.1) Except as provided under paragraph (1) of subsection (j) of this Code section, the

- 13 <u>following proclamation shall govern the simple possession of marijuana:</u>
- 14 'Acting pursuant to the grant of authority in Article II, Section 2, of the Constitution of
- 15 the United States, the Office of the President of the United States, does hereby grant a
- 16 <u>full, complete, and unconditional pardon to (1) all current United States citizens and</u>

| 17 | lawful permanent residents who committed the offense of simple possession of marijuana |

| 24 | of the Controlled Substances Act, as currently codified at 21 U.S.C. 844 and as |
| 25 | previously codified elsewhere in the United States Code, or in violation of D.C. Code |
| 26 | 48–904.01(d)(1); which pardon shall restore to them full political, civil, and other rights. |
| 27 | The proclamation is to pardon only the offense of simple possession of marijuana in |
| 28 | violation of Federal law or in violation of D.C. Code 48-904.01(d)(1), and not any other |
| 29 | offenses related to marijuana or other controlled substances. No language herein shall |
| 30 | be construed to pardon any person for any other offense, including possession of other |
| 31 | controlled substances, whether committed prior, subsequent, or contemporaneous to the |
| 32 | pardoned offense of simple possession of marijuana. |
| 33 | Pursuant to this proclamation, the Attorney General, acting through the Pardon Attorney, |
| 34 | shall administer and effectuate the issuance of certificates of pardon to eligible applicants |
| 35 | who have been charged or convicted for the offense of simple possession of marijuana |
| 36 | in violation of the Controlled Substances Act, as currently codified at 21 U.S.C. 844 and |
| 37 | as previously codified elsewhere in the United States Code, or in violation of D.C. Code |
| 38 | 48-904.01(d)(1). The Attorney General, acting through the Pardon Attorney, is directed |
| 39 | to develop and announce application procedures for certificates of pardon and to begin |
| 40 | accepting applications in accordance with such procedures as soon as reasonably |
| 41 | practicable. The Attorney General, acting through the Pardon Attorney, shall review all |
| 42 | properly submitted applications and shall issue certificates of pardon to eligible |
| 43 | applicants in due course." |
