

House Bill 513

A BILL TO BE ENTITLED
AN ACT

1 To amend Part 2 of Article 6 of Chapter 2 of Title 20 of the Official Code of Georgia
2 Annotated, relating to competencies and core curriculum under the "Quality Basic Education
3 Act," so as to provide that the prescribed course of study in sex education and HIV
4 prevention instruction is age appropriate; to include the subject of consent in such course of
5 study; to provide for implementation; to provide for related matters; to repeal conflicting
6 laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 Part 2 of Article 6 of Chapter 2 of Title 20 of the Official Code of Georgia Annotated,
10 relating to competencies and core curriculum under the "Quality Basic Education Act," is
11 amended by revising Code Section 20-2-143, relating to sex education and AIDS prevention
12 instruction, implementation, and student exemption, as follows:

13 "20-2-143.

14 (a) Each local board of education shall prescribe a an age-appropriate course of study in
15 sex education and ~~AIDS~~ human immunodeficiency virus (HIV) prevention instruction for
16 such grades and grade levels in the public school system as shall be determined by the State

17 Board of Education. Such course of study shall implement either the minimum course of
18 study provided for in subsection (b) of this Code section or its equivalent, as approved by
19 the State Board of Education. Each local board of education shall be authorized to
20 supplement and develop the exact approach of content areas of such minimum course of
21 study with such specific curriculum standards as it may deem appropriate. Such standards
22 shall include age-appropriate instruction relating to the handling of peer pressure, the
23 promotion of high self-esteem, local community values, the legal consequences of
24 parenthood, and abstinence from sexual activity as an effective method of prevention of
25 pregnancy, sexually transmitted diseases, and ~~acquired immune deficiency syndrome~~
26 human immunodeficiency virus (HIV).

27 (b) The State Board of Education shall prescribe a an age-appropriate minimum course of
28 study in sex education and ~~AIDS~~ human immunodeficiency virus (HIV) prevention
29 instruction which may be included as a part of a course of study in comprehensive health
30 education for such grades and grade levels in the public school system as shall be
31 determined by the state board and shall establish standards for its administration. The
32 course may include age-appropriate instruction concerning human biology, conception,
33 pregnancy, birth, sexually transmitted diseases, and ~~acquired immune deficiency syndrome~~
34 human immunodeficiency virus (HIV). The course shall include age-appropriate instruction
35 concerning the legal consequences of parenthood, including, without being limited to, the
36 legal obligation of both parents to support a child and legal penalties or restrictions upon
37 failure to support a child, including, without being limited to, the possible suspension or
38 revocation of a parent's driver's license and occupational or professional licenses. The
39 course shall ~~also~~ include annual age-appropriate instruction for students in kindergarten
40 through grade nine concerning the awareness and prevention of sexual abuse and assault
41 ~~awareness and prevention education in kindergarten through grade nine~~. A manual setting
42 out the details of such course of study shall be prepared by or approved by the State School

43 Superintendent in cooperation with the Department of Public Health, the State Board of
44 Education, and such expert advisers as they may choose.

45 (c) The minimum course of study to be prescribed by the State Board of Education
46 pursuant to subsection (b) of this Code section shall be ready for implementation not later
47 than ~~July 1, 1988~~ August 1, 2023. Each local board shall implement either such minimum
48 course of study or its equivalent not later than July 1, ~~1989~~ 2024. Any local board of
49 education which fails to comply with this subsection shall not be eligible to receive any
50 state funding under this article until such minimum course of study or its equivalent has
51 been implemented.

52 (d) Any parent or legal guardian of a child to whom the course of study set forth in this
53 Code section is to be taught shall have the right to elect, in writing, that such child not
54 receive such course of study."
