A BILL TO BE ENTITLED AN ACT

- 1 To amend Chapter 2 of Title 21 of the Official Code of Georgia Annotated, relating to
- 2 primaries and elections generally, so as to provide for preferential treatment during advance
- 3 voting to voters accompanied by children of five years of age or under; to provide for
- 4 preferential treatment during certain hours on election day to voters accompanied by children
- 5 of five years of age or under; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.

- 8 Chapter 2 of Title 21 of the Official Code of Georgia Annotated, relating to primaries and
- 9 elections generally, is amended by revising Code Section 21-2-385.1, relating to preferential
- 10 treatment for older and disabled voters, as follows:
- 11 "21-2-385.1.

- During the period of advance voting established pursuant to subsection (d) of Code
- 13 Section 21-2-385, each elector who is 75 years of age or older, who is accompanied by one
- or more children of five years of age or under, or who is disabled and requires assistance
- in casting an absentee ballot in person at the registrar's office, absentee ballot clerk's office,
- or other locations as provided for in Code Section 21-2-382 shall, upon request to a

designated office employee or other individual, be authorized to vote immediately at the next available voting compartment or booth without having to wait in line if such location utilizes direct recording electronic voting systems or be authorized to go to the head of any 19 line necessary to cast a written absentee ballot. Notice of the provisions of this Code section shall be prominently displayed in the registrar's office or absentee ballot clerk's office."

23 **SECTION 2.**

- 24 Said chapter is further amended by revising Code Section 21-2-409.1, relating to voting by
- 25 electors who are 75 years of age or older or disabled electors without having to wait in line,
- 26 as follows:

- "21-2-409.1. 27
- 28 On election day between the hours of 9:30 A.M. and 4:30 P.M., each elector who is 75
- 29 years of age or older, who is accompanied by one or more children of five years of age or
- 30 under, or who is disabled and requires assistance in voting as authorized by Code Section
- 31 21-2-409, shall, upon request to a poll officer, be authorized at any primary or election to
- 32 vote immediately at the next available voting compartment or booth without having to wait
- 33 in line. Notice of the provisions of this Code section shall be prominently displayed in the
- 34 voting place."

35 **SECTION 3.**

All laws and parts of laws in conflict with this Act are repealed. 36
