

House Bill 601 (COMMITTEE SUBSTITUTE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act providing for a new charter for the City of Sandy Springs in Fulton County,  
2 approved April 15, 2005 (Ga. L. 2005, p. 3515), as amended, so as to change the description  
3 of the election districts for the city council; to provide for definitions and inclusions; to  
4 provide for continuation in office of current members; to revise the compensation of the  
5 mayor and councilmembers; to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 An Act providing for a new charter for the City of Sandy Springs in Fulton County, approved  
9 April 15, 2005 (Ga. L. 2005, p. 3515), as amended, is amended by revising subsection (c) of  
10 Section 2.01 as follows:

11 "(c)(1) Each city councilmember shall be elected by a majority vote of the qualified  
12 electors of his or her respective city council district voting at the elections of the city. For  
13 the purpose of electing the six city councilmembers, there shall be six city council  
14 districts. Districts 1, 2, 3, 4, 5, and 6 shall be and correspond to those six numbered  
15 districts described in Appendix B attached to and made a part of this Act and further  
16 identified as 'User: Sandy Springs Plan Name: SandySprings-2023 Plan Type: Local'.

17 Each person desiring to offer as a candidate for city councilmember shall designate the  
18 city council district for which he or she is offering.

19 (2)(A) For the purposes of such plan:

20 (i) The term 'VTD' shall mean and describe the same geographical boundaries as  
21 provided in the report of the Bureau of the Census for the United States decennial  
22 census of 2020 for the State of Georgia. The separate numeric designations in a  
23 district description which are underneath a VTD heading shall mean and describe  
24 individual Blocks within a VTD as provided in the report of the Bureau of the Census  
25 for the United States decennial census of 2020 for the State of Georgia; and

26 (ii) Except as otherwise provided in the description of any district, whenever the  
27 description of any district refers to a named city, it shall mean the geographical  
28 boundaries of that city as shown on the census maps for the United States decennial  
29 census of 2020 for the State of Georgia.

30 (B) Any part of the City of Sandy Springs which is not included in any district  
31 described in paragraph (1) of this subsection shall be included within that district  
32 contiguous to such part which contains the least population according to the United  
33 States decennial census of 2020 for the State of Georgia.

34 (3) Except for incorporated islands of the City of Sandy Springs, any part of the City of  
35 Sandy Springs which is described in paragraph (1) of this subsection as being included  
36 in a particular district shall nevertheless not be included within such district if such part  
37 is not contiguous to such district. Such noncontiguous part shall instead be included  
38 within that district contiguous to such part which contains the least population according  
39 to the United States decennial census of 2020 for the State of Georgia.

40 (4)(A) Those members of the city council who are serving as such on the effective date  
41 of this Act and any person selected to fill a vacancy in any such office shall continue  
42 to serve as such members until the regular expiration of their respective terms of office  
43 and upon the election and qualification of their respective successors.

44 (B) Districts 1, 2, 3, 4, 5, and 6, as they exist immediately prior to the effective date of  
45 this Act, shall continue to be designated as Districts 1, 2, 3, 4, 5, and 6, respectively, but  
46 as newly described under this Act, and on and after the effective date of this Act, such  
47 members of the council serving from those former districts shall be deemed to be  
48 serving from and representing their respective districts as newly described under this  
49 Act."

50 **SECTION 2.**

51 Said Act is further amended by revising Section 2.07 as follows:

52 "SECTION 2.07.

53 Compensation and expenses.

54 Effective July 1, 2023, the starting salary of the mayor shall not be less than \$42,000.00  
55 and the starting salary for each city councilmember shall not be less than \$26,000.00. Such  
56 salary shall be paid from municipal funds in monthly installments. The city council shall  
57 have authority to vote annually to raise the mayor's and city councilmembers' salaries in  
58 an amount consistent with the Consumer Price Index or similar inflationary index. The city  
59 council may provide by ordinance for the provision of insurance, retirement, workers'  
60 compensation, and other employee benefits to the mayor and city councilmembers and may  
61 provide by ordinance for the reimbursement of expenses actually and necessarily incurred  
62 by the mayor and city councilmembers in carrying out their official duties."

63 **SECTION 3.**

64 All laws and parts of laws in conflict with this Act are repealed.
