A BILL TO BE ENTITLED AN ACT

To amend an Act to provide a new charter for the City of Thomasville, approved March 30, 1990 (Ga. L. 1990, p. 5051), as amended, so as to reapportion the city council and board of

3 education election districts; to provide for definitions and inclusions; to provide for

4 continuation in office of current members; to provide for related matters; to repeal conflicting

5 laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.

8 An Act to provide a new charter for the City of Thomasville, approved March 30, 1990 (Ga.

9 L. 1990, p. 5051), as amended, is amended by revising Section 5.22 as follows:

10 "SECTION 5.22.

Boundaries of council districts.

12 (a) For the purpose of electing district councilmembers of the city council, the City of

13 Thomasville shall be divided into two election districts. Those election districts shall be

and correspond to those two numbered districts described in Appendix A attached to and

made a part of this Act and further identified as 'User: Thomasville City Plan Name:

 - (b)(1) For the purposes of such plan:

- (A) The term 'VTD' shall mean and describe the same geographical boundaries as provided in the report of the Bureau of the Census for the United States decennial census of 2020 for the State of Georgia. The separate numeric designations in an
- election district description which are underneath a VTD heading shall mean and
- describe individual Blocks within a VTD as provided in the report of the Bureau of the
- Census for the United States decennial census of 2020 for the State of Georgia; and
- 24 (B) Except as otherwise provided in the description of any election district, whenever
- 25 the description of any election district refers to a named city, it shall mean the
- 26 geographical boundaries of that city as shown on the census maps for the United States
- decennial census of 2020 for the State of Georgia.
- 28 (2) Any part of the City of Thomasville which is not included in any election district
- described in subsection (a) of this section shall be included within that election district
- 30 contiguous to such part which contains the least population according to the United States
- decennial census of 2020 for the State of Georgia.
- 32 (3) Except for any incorporated islands, any part of the City of Thomasville which is
- described in subsection (a) of this section as being included in a particular election district
- 34 shall nevertheless not be included within such election district if such part is not
- contiguous to such election district. Such noncontiguous part shall instead be included
- within that election district contiguous to such part which contains the least population
- according to the United States decennial census of 2020 for the State of Georgia."

38 SECTION 2.

39 Said Act is further amended by revising Section 11.10 as follows:

Boundaries of board districts.

- (a) For the purpose of electing district board members of the board of education, the City of Thomasville Independent School District shall be divided into two education election districts. Those election districts shall be and correspond to those two numbered districts described in Appendix A attached to and made a part of this Act and further identified as 'User: Thomasville City Plan Name: Thomasville CCSB-2022 Plan Type: Local'.
 - (b)(1) For the purposes of such plan:

- (2) Any part of the City of Thomasville Independent School District which is not included in any education election district described in subsection (a) of this section shall be included within that election district contiguous to such part which contains the least population according to the United States decennial census of 2020 for the State of Georgia.
- (3) Except for any incorporated islands, any part of the City of Thomasville Independent School District which is described in subsection (a) of this section as being included in a particular education election district shall nevertheless not be included within such

education election district if such part is not contiguous to such election district. Such noncontiguous part shall instead be included within that election district contiguous to such part which contains the least population according to the United States decennial census of 2020 for the State of Georgia."

70 SECTION 3.

- 71 (a) Those members of the City Council of the City of Thomasville and the Board of
- 72 Education of the City of Thomasville Independent School District who are serving as such
- 73 on the effective date of this Act and any person selected to fill a vacancy in any such office
- shall continue to serve as such members until the regular expiration of their respective terms
- of office and upon the election and qualification of their respective successors.
- 76 (b) City Council Election Districts 1 and 2, as they exist immediately prior to the effective
- date of this Act, shall continue to be designated as City Council Election Districts 1 and 2,
- 78 respectively, but as newly described under this Act, and on and after the effective date of this
- 79 Act, such councilmembers serving from those former election districts shall be deemed to
- 80 be serving from and representing their respective election districts as newly described under
- 81 this Act.

- 82 (c) Education Election Districts 1 and 2, as they exist immediately prior to the effective date
- 83 of this Act, shall continue to be designated as Education Election Districts 1 and 2,
- 84 respectively, but as newly described under this Act, and on and after the effective date of this
- 85 Act, such members of the board of education serving from those former election districts
- shall be deemed to be serving from and representing their respective election districts as
- 87 newly described under this Act.

88 SECTION 4.

89 All laws and parts of laws in conflict with this Act are repealed.
