## A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act to create the Henry County Governmental Services Authority, approved
- 2 May 6, 2005 (Ga. L. 2005, p. 4014), as amended, particularly by an Act approved April 20,
- 3 2011 (Ga. L. 2011, p. 3722), so as to expand the purpose of the authority to include providing
- 4 stormwater facilities and undertakings as defined by the Revenue Bond Law; to provide for
- 5 definitions; to provide for related matters; to repeal conflicting laws; and for other purposes.

## 6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.

- 8 An Act to create the Henry County Governmental Services Authority, approved May 6, 2005
- 9 (Ga. L. 2005, p. 4014), as amended, particularly by an Act approved April 20, 2011 (Ga. L.
- 10 2011, p. 3722), is amended by revising paragraphs (3) and (4) and adding a new paragraph
- 11 to Section 3 as follows:
- 12 "(3) 'Project' means:
- 13 (A) Roads, streets, and bridges necessary or convenient for efficient surface
- transportation in Henry County, Georgia, and any other political subdivision of the
- 15 State of Georgia located within Henry County, Georgia;
- 16 (B) Public airports and landing fields for the use of aircraft, related buildings and
- structures, and facilities, buildings, and structures usual or convenient to be located at
- or co-located with such undertakings, extensions, and improvements of such facilities,
- and the acquiring of necessary or convenient property, both real and personal, so as to
- assure the efficient and proper development, maintenance, and operation of such
- desirable for the operation of such airports and landing fields anywhere within or for

airports and landing fields deemed by the authority to be necessary, convenient, or

- 24 (C) Stormwater facilities;
- 25 (D) Undertakings, as that term is now or hereafter defined in the Revenue Bond Law;

29	(4) 'Revenue Bond Law' means the Revenue Bond Law of the State of Georgia codified
30	at O.C.G.A. Section 36-82-60 et seq., now or as hereafter amended, or any other similar
31	law hereinafter enacted."
32	"(8) 'Stormwater facility' means facilities to aid in the transmittal, distribution, detention,
33	retention, and conveyance of stormwater, including, without limitation, detention and
34	retention ponds, creeks, rivers, lakes, dams, ditches, and culverts and related facilities,
35	extensions, and improvements of such facilities whether on public or private property,
36	and the acquiring of necessary or convenient property, both real and personal, so as to
37	assure the efficient and proper development, maintenance, repair, and operation of such
38	facilities and appurtenances thereto deemed by the authority to be necessary, convenient,
39	or desirable for the proper transmittal, distribution, detention, retention, and conveyance
40	of stormwater anywhere within or for Henry County, Georgia."
41	SECTION 2.
42	Said Act is further amended by revising Section 23 as follows:
43	"SECTION 23.
44	Purpose of the authority.
45	Without limiting the generality of any provision of this Act, the general purpose of the
46	authority is declared to be that of providing public airports, landing fields, and associated
47	properties and facilities, roads, streets, bridges, stormwater facilities, and other undertakings
48	now or hereafter permitted by the Revenue Bond Law, benefitting the residents of Henry
