A BILL TO BE ENTITLED AN ACT

- 1 To amend Code Section 12-8-22 of the Official Code of Georgia Annotated, relating to
- 2 definitions relative to solid waste management, so as to modify certain definitions and enact
- 3 new definitions; to provide for related matters; to repeal conflicting laws; and for other
- 4 purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6	SECTION 1.
7	Code Section 12-8-22 of the Official Code of Georgia Annotated, relating to definitions
8	relative to solid waste management, is amended by revising paragraphs (25), (26), (27), (34),
9	and (35) and by adding new paragraphs to read as follows:
10	"(9.1) 'Feedstock' means raw material that is used in a machine or industrial process."
11	"(10.1) 'Gasification to fuels and chemicals' means a process through which recovered
12	materials or other nonrecycled feedstock is heated and converted into a fuel-gas mixture
13	in an oxygen-deficient atmosphere, and such mixture is converted into fuel, including
14	ethanol and transportation fuel, chemicals, or other chemical feedstocks.
15	(10.2) 'Gasification to fuels and chemicals facility' means a facility that collects.
16	separates, stores, or converts nonrecycled feedstock into fuels, chemicals, or other
17	valuable final or intermediate products using a gasification to fuels and chemicals
18	process. Such term shall not be considered a waste handling facility or solid waste
19	thermal treatment facility."
20	"(20.1) 'Nonrecycled feedstock' means one or more of the following materials, derived
21	from nonrecycled materials, that has been processed so that it may be used as a feedstock
22	in a gasification to fuels and chemicals facility, but excluding coal refuse and scrap tires:
23	(A) Post-use plastics; or
24	(B) Materials for which the Environmental Protection Agency has made a nonwaste
25	determination under 40 C.F.R. Section 241.3(c) or that are otherwise determined not
26	to constitute waste "

27 "(22.1) 'Post-use plastics' means recovered plastics, derived from any source, that are not being used for their originally intended purpose and that might otherwise become waste 28 29 if not processed at a pyrolysis or gasification to fuels and chemicals facility or recycled, 30 and the term includes plastics that may contain incidental contaminants or impurities such as paper labels or metal rings." 31 32 "(24.1) 'Pyrolysis' means a process through which post-use plastics are heated, in an 33 oxygen-free environment, until melted and thermally decomposed, then cooled, condensed, and converted into oil, diesel, gasoline, home heating oil, or other liquid fuel; 34 gasoline or diesel blendstock; chemicals or chemical feedstock; waxes or lubricants; or 35 36 other similar raw materials or intermediate or final products. (24.2) 'Pyrolysis facility' means a facility that collects, separates, stores, or converts 37 38 post-use plastics into fuels or other valuable final or intermediate products using a 39 pyrolysis process. Pyrolysis facilities shall not be considered solid waste handling facilities or solid waste thermal treatment facilities. 40 41 (25) 'Recovered materials' means those materials which have known use, reuse, or recycling potential; can be feasibly used, reused, or recycled; and have been diverted or 42 removed from the solid waste stream for sale, use, reuse, or recycling, whether or not 43 44 requiring subsequent separation and processing. Recovered materials include post-use 45 plastics and nonrecycled feedstock that are subsequently processed using a pyrolysis or gasification to fuels and chemicals process. 46 47 (26) 'Recovered materials processing facility' means a facility engaged solely in the 48 storage, processing, recycling, and resale or reuse of recovered materials. Recovered 49 materials processing facilities include pyrolysis and gasification to fuels and chemicals 50 facilities. Such term shall not include a solid waste handling facility; provided, however, 51 that any solid waste generated by such facility shall be subject to all applicable laws and 52 regulations relating to such solid waste. (27) 'Recycling' means any process by which materials which would otherwise become 53 solid waste are collected, separated, or processed and reused or returned to use in the 54 form of raw materials, intermediates, or products, including fuels, fuel substitutes, and 55 other products of pyrolysis and gasification to fuels and chemicals processes." 56 57 "(34) 'Solid waste handling' means the storage, collection, transportation, treatment, 58 utilization, processing, or disposal of solid waste or any combination of such activities, 59 but does not include pyrolysis or gasification to fuels and chemicals processes or the holding of post-use plastics or nonrecycled feedstock at a pyrolysis facility or gasification 60 to fuels and chemicals facility prior to processing at the facility where those materials are 61 62 being held to ensure production is not interrupted.

(35) 'Solid waste handling facility' means any facility the primary purpose of which is
 the storage, collection, transportation, treatment, utilization, processing, or disposal, or
 any combination thereof, of solid waste, but does not include pyrolysis or gasification to
 fuels and chemicals facilities."

All laws and parts of laws in conflict with this Act are repealed.
