## A BILL TO BE ENTITLED AN ACT

- 1 To amend Chapter 1 of Title 9 of the Official Code of Georgia Annotated, relating to general
- 2 provisions regarding civil practice, so as to enact the "Uniform Unsworn Declarations Act";
- 3 to provide for unsworn declarations to have the same effect as sworn declarations in certain
- 4 circumstances; to provide for exceptions; to provide for definitions; to provide for
- 5 applicability and construction; to provide for a short title; to amend Article 4 of Chapter 10
- 6 of Title 16 of the Official Code of Georgia Annotated, relating to perjury and related
- 7 offenses, so as to include unsworn declarations in the offense of perjury; to provide for
- 8 applicability; to provide for related matters; to provide for an effective date; to repeal
- 9 conflicting laws; and for other purposes.

## 10 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

- 12 Chapter 1 of Title 9 of the Official Code of Georgia Annotated, relating to general provisions
- 13 regarding civil practice, is amended by adding a new Code section to read as follows:

- 14 <u>"9-1-1.</u>
- 15 (a) This Code section shall be known and may be cited as the 'Uniform Unsworn
- 16 Declarations Act.'
- 17 (b) As used in this Code section, the term:
- 18 (1) 'Law' includes a statute, judicial decision or order, rule of court, executive order, and
- 19 <u>administrative rule, regulation, or order.</u>
- 20 (2) 'Record' means information that is inscribed on a tangible medium or that is stored
- in an electronic or other medium and is retrievable in perceivable form.
- 22 (3) 'Sign' means, with present intent to authenticate or adopt a record:
- 23 (A) To execute or adopt a tangible symbol; or
- 24 (B) To attach to or logically associate with the record an electronic symbol, sound, or
- 25 process.
- 26 (4) 'Sworn declaration' means a declaration in a signed record given under oath. Such
- 27 <u>term includes a sworn statement, verification, certificate, and affidavit.</u>
- 28 (5) 'Unsworn declaration' means a declaration in a signed record not given under oath but
- 29 given under penalty of perjury.
- 30 (c) Except as provided in subsection (d) of this Code section or otherwise precluded by
- 31 <u>law, this Code section shall apply to an unsworn declaration by a declarant who at the time</u>
- 32 of making the declaration is physically located outside the boundaries of the United States,
- 33 Puerto Rico, the United States Virgin Islands, and any territory or insular possession
- 34 <u>subject to the jurisdiction of the United States.</u>
- 35 (d)(1) Except as otherwise provided in paragraph (2) of this subsection, if a law of this
- 36 <u>state requires or permits use of a sworn declaration in a court, administrative, or arbitral</u>
- 37 proceeding, an unsworn declaration meeting the requirements of this Code section has
- 38 the same effect as a sworn declaration.
- 39 (2) This Code section shall not apply to:
- 40 (A) A deposition;
- 41 (B) An oath of office;

42 (C) An oath expressly required by statute to be given before a specified official other 43 than a notary public; 44 (D) An oath expressly required by statute to be made pursuant to the requirements of 45 Code Section 9-10-113; (E) An instrument expressly required by statute to comply with Code Section 44-2-15; 46 47 or 48 (F) An oath required by Code Section 53-4-24. 49 (e) If a law of this state requires that a sworn declaration be presented in a particular medium, an unsworn declaration must be presented in the same medium. 50 51 (f) An unsworn declaration under this Code section shall be in form and content 52 substantially as follows: 53 I declare under penalty of perjury under the law of Georgia that the foregoing is true and 54 correct, and that I am physically located outside the geographic boundaries of the United 55 States, Puerto Rico, the United States Virgin Islands, and any territory or insular 56 possession subject to the jurisdiction of the United States. Section 7001, et seg., but does not modify, 68 limit, or supersede Section 101(c) of such act, or authorize electronic delivery of any of the notices described in Section 103(b) of such act." 69

70 **SECTION 2.** 

- 71 Article 4 of Chapter 10 of Title 16 of the Official Code of Georgia Annotated, relating to
- 72 perjury and related offenses, is amended by revising subsection (a) of Code Section
- 73 16-10-70, relating to perjury, as follows:
- 74 "(a) A person to whom a lawful oath or affirmation has been administered <u>or a person who</u>
- 75 executes an unsworn declaration as defined in Code Section 9-1-1 commits the offense of
- 76 perjury when, in a judicial proceeding, he or she knowingly and willfully makes a false
- statement material to the issue or point in question."

78 SECTION 3.

79 This Act shall become effective July 1, 2023.

SECTION 4.

81 All laws and parts of laws in conflict with this Act are repealed.
