A BILL TO BE ENTITLED AN ACT

- 1 To amend Code Section 31-2A-18 of the Official Code of Georgia Annotated, relating to the
- 2 establishment of the Low THC Oil Patient Registry, definitions, purpose, registration cards,
- 3 semiannual reports, and waiver forms, so as to change provisions relating to conditions and
- 4 eligibility; to provide for related matters; to repeal conflicting laws; and for other purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 SECTION 1.

- 7 Code Section 31-2A-18 of the Official Code of Georgia Annotated, relating to the
- 8 establishment of the Low THC Oil Patient Registry, definitions, purpose, registration cards,
- 9 semiannual reports, and waiver forms, is amended by revising paragraph (3) as follows:
- 10 "(3) 'Condition' means:
- 11 (A) Cancer, when such disease is diagnosed as end stage or the treatment produces
- related wasting illness or recalcitrant nausea and vomiting;
- 13 (B) Amyotrophic lateral sclerosis, when such disease is diagnosed as severe or end
- stage;
- 15 (C) Seizure disorders related to a diagnosis of epilepsy or trauma related head injuries;
- 16 (D) Multiple sclerosis, when such disease is diagnosed as severe or end stage;
- 17 (E) Crohn's disease;
- 18 (F) Mitochondrial disease;
- 19 (G) Parkinson's disease, when such disease is diagnosed as severe or end stage;
- 20 (H) Sickle cell disease, when such disease is diagnosed as severe or end stage;
- 21 (I) Tourette's syndrome, when such syndrome is diagnosed as severe;
- 22 (J) Autism spectrum disorder, when such disorder is diagnosed for a patient who is at
- least 18 years of age, or severe autism, when diagnosed for a patient who is less than 18
- years of age;
- 25 (K) Epidermolysis bullosa;
- 26 (L) Alzheimer's disease, when such disease is diagnosed as severe or end stage;
