

House Bill 876 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED

AN ACT

1 To amend an Act providing authority for members of the Board of Education of Barrow
2 County, approved April 10, 1971 (Ga. L. 1971, p. 3919), as amended, particularly by an Act
3 approved September 7, 2011 (Ga. L. 2011 Ex. Sess., p. 272), so as to change the composition
4 of the election districts from which the members of the Board of Education of Barrow
5 County are elected; to define certain terms; to provide for continuation in office of persons
6 serving as members of the board on a certain date; to provide for related matters; to repeal
7 conflicting laws; and for other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **SECTION 1.**

10 An Act providing authority for members of the Board of Education of Barrow County,
11 approved April 10, 1971 (Ga. L. 1971, p. 3919), as amended, particularly by an Act approved
12 September 7, 2011 (Ga. L. 2011 Ex. Sess., p. 272), is amended by revising subsections (b)
13 and (d) of Section 2 as follows:

14 "(b)(1)(A) For purposes of electing members of the Board of Education of Barrow
15 County under this section, the Barrow County School District shall be divided into nine
16 education districts.

17 (B) Education Districts 1, 2, 3, 4, 5, and 6 shall consist of the described territory of the
18 Barrow County School District provided for in Appendix A attached to and made a part
19 of this Act and further identified as 'User: Barrow Plan Name: barrowccsb-2022 Plan
20 Type: Local'. Each member representing any such district shall be elected by the
21 qualified electors residing in that district only.

22 (C) Education Districts 7, 8, and 9 shall each be an at-large district composed of the
23 entire territory within the Barrow County School District. Each member representing
24 any such district shall be elected by the qualified electors of the entire school district.

25 (2)(A) When used in such appendix, the term 'VTD' shall mean and describe the same
26 geographical boundaries as provided in the report of the Bureau of the Census for the
27 United States decennial census of 2020 for the State of Georgia. The separate numeric
28 designations in a district description which are underneath a VTD heading shall mean
29 and describe individual Blocks within a VTD as provided in the report of the Bureau
30 of the Census for the United States decennial census of 2020 for the State of Georgia;
31 and

32 (B) Except as otherwise provided in the description of any district, whenever the
33 description of any district refers to a named city, it shall mean the geographical
34 boundaries of that city as shown on the census maps for the United States decennial
35 census of 2020 for the State of Georgia.

36 (2) Any part of the Barrow County School District which is not included in any district
37 described in subparagraph (B) of paragraph (1) of this subsection shall be included within
38 that district contiguous to such part which contains the least population according to the
39 United States decennial census of 2020 for the State of Georgia.

40 (3) Any part of the Barrow County School District which is described in
41 subparagraph (B) of paragraph (1) of this subsection as being included in a particular
42 district shall nevertheless not be included within such district if such part is not
43 contiguous to such district. Such noncontiguous part shall instead be included within that

44 district contiguous to such part which contains the least population according to the
45 United States decennial census of 2020 for the State of Georgia.”

46 “(d)(1) The members of the board serving in office on the effective date of this Act and
47 any person selected to fill a vacancy in any such office shall continue to serve until the
48 expiration of the term for which they were elected and until their successors are elected
49 and qualified.

50 (2) All members of the board shall be elected from the education districts described in
51 subsection (b) of this section.

52 (3) Members of the board representing Education Districts 1, 3, 4, 7, and 9 shall be
53 elected at the general election in 2022 and quadrennially thereafter and shall take office
54 on the first day of January immediately following their election for terms of four years
55 and until their successors are elected and qualified.

56 (4) Members of the board representing Education Districts 2, 5, 6, and 8 shall be elected
57 at the general election in 2024 and quadrennially thereafter and shall take office on the
58 first day of January immediately following their election for terms of four years and until
59 their successors are elected and qualified.”

60 **SECTION 2.**

61 Districts 1, 2, 3, 4, 5, 6, 7, 8, and 9 as they exist immediately prior to the effective date of this
62 Act shall continue to be designated as Districts 1, 2, 3, 4, 5, 6, 7, 8, and 9, respectively, but
63 as newly described under this Act, and on and after the effective date of this Act, such
64 members of the board serving from those former districts shall be deemed to be serving from
65 and representing their respective districts as newly described under this Act.

66 **SECTION 3.**

67 Said Act is further amended by striking in its entirety the attachment thereto containing the
68 descriptions of education districts which is identified as "Plan: barrowccsb-2011 Plan Type:
69 Local User: admin".

70 **SECTION 4.**

71 All laws and parts of laws in conflict with this Act are repealed.
