## A BILL TO BE ENTITLED AN ACT

- 1 To amend Code Section 39-5-2 of the Official Code of Georgia Annotated, relating to
- 2 notification to subscribers of products that limit, restrict, or monitor a minor's use of the
- 3 Internet, so as to provide that an operator of an Internet website, online service, online
- 4 application, or mobile application that has actual or constructive knowledge that a minor is
- 5 using its services shall permit the minor to remove posted information; to provide for notices;
- 6 to provide for instructions; to repeal conflicting laws; and for other purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 Code Section 39-5-2 of the Official Code of Georgia Annotated, relating to notification to
- 10 subscribers of products that limit, restrict, or monitor a minor's use of the Internet, is
- amended by adding a new subsection to read as follows:
- 12 "(b.1) An operator of an Internet website, online service, online application, or mobile
- 13 application that has actual or constructive knowledge that a minor is using its Internet
- 14 website, online service, online application, or mobile application shall do all of the
- 15 <u>following:</u>

- 16 (1) Permit a minor who is a registered user of the operator's Internet website, online
- service, online application, or mobile application to remove or, if the operator prefers, to
- request and obtain removal of, content or information posted on the operator's Internet
- website, online service, online application, or mobile application by the user;
- 20 (2) Provide notice to a minor who is a registered user of the operator's Internet website,
- 21 <u>online service, online application, or mobile application that the minor may remove or,</u>
- if the operator prefers, request and obtain removal of, content or information posted on
- 23 <u>the operator's Internet website, online service, online application, or mobile application</u>
- by the registered user;
- 25 (3) Provide clear instructions to a minor who is a registered user of the operator's Internet
- website, online service, online application, or mobile application on how the user may
