A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act providing for the election of members of the Board of Education of Wilkes
- 2 County, approved March 18, 1986 (Ga. L. 1986, p. 4091), as amended, particularly by an Act
- 3 approved September 21, 2011 (Ga. L. 2011 Ex. Sess., p. 432), so as to change the description
- 4 of the education districts; to provide for continuation in office of certain current board
- 5 members; to provide for effective dates; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.

- 8 An Act providing for the election of members of the Board of Education of Wilkes County,
- 9 approved March 18, 1986 (Ga. L. 1986, p. 4091), as amended, particularly by an Act
- approved September 21, 2011 (Ga. L. 2011 Ex. Sess., p. 432), is amended by revising
- 11 subsections (c) and (d) of Section 1 as follows:
- 12 "(c) For purposes of electing members of the board of education, other than the
- chairperson, the Wilkes County School District is divided into four education districts.
- One member of the board shall be elected from each such district. The four education
- districts shall be and correspond to those four numbered districts described in Appendix A

attached to and made a part of this Act and further identified as 'User: Wilkes Co. Plan

- 17 Name: WilkesCCSB-2022 Plan Type: Local'.
- 18 (d)(1) For the purposes of such plan:
- 19 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
- provided in the report of the Bureau of the Census for the United States decennial
- 21 census of 2020 for the State of Georgia. The separate numeric designations in a district
- description which are underneath a VTD heading shall mean and describe individual
- Blocks within a VTD as provided in the report of the Bureau of the Census for the
- United States decennial census of 2020 for the State of Georgia; and
- 25 (B) Except as otherwise provided in the description of any district, whenever the
- description of any district refers to a named city, it shall mean the geographical
- boundaries of that city as shown on the census maps for the United States decennial
- census of 2020 for the State of Georgia.
- 29 (2) Any part of the Wilkes County School District which is not included in any district
- described in subsection (c) of this section shall be included within that district contiguous
- 31 to such part which contains the least population according to the United States decennial
- census of 2020 for the State of Georgia.
- 33 (3) Any part of the Wilkes County School District which is described in subsection (c)
- of this section as being included in a particular district shall nevertheless not be included
- within such district if such part is not contiguous to such district. Such noncontiguous
- part shall instead be included within that district contiguous to such part which contains
- 37 the least population according to the United States decennial census of 2020 for the State
- 38 of Georgia."

39 SECTION 2.

40 Said Act is further amended by repealing and reserving subsection (c) of Section 3.

41 SECTION 3.

- 42 (a) Those members of the Board of Education of Wilkes County who are serving as such on
- 43 the effective date of this Act and any person selected to fill a vacancy in any such office shall
- 44 continue to serve as such members until the regular expiration of their respective terms of
- 45 office and upon the election and qualification of their respective successors.
- 46 (b) Districts 1, 2, 3, and 4, as they exist immediately prior to the effective date of this Act,
- 47 shall continue to be designated as Districts 1, 2, 3, and 4, respectively, but as newly described
- 48 under this Act, and on and after the effective date of this Act, such members of the board
- 49 serving from those former districts shall be deemed to be serving from and representing their
- 50 respective districts as newly described under this Act.

SECTION 4.

- 52 The provisions of this Act necessary to conduct elections for the members of the Board of
- 53 Education of Wilkes County in 2022 shall become effective upon the approval of this Act
- 54 by the Governor or upon its becoming law without such approval. The remaining provisions
- of this Act shall become effective on January 1, 2023.

56 **SECTION 5.**

57 All laws and parts of laws in conflict with this Act are repealed.
