A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act creating the Board of Commissioners of Lincoln County, approved
- 2 February 25, 1949 (Ga. L. 1949, p. 1228), as amended, particularly by an Act approved
- 3 April 5, 2002 (Ga. L. 2002, p. 4909) and by an Act approved March 27, 2012
- 4 (Ga. L. 2012, p. 4561), so as to change the description of the commissioner districts; to
- 5 define certain terms and provide for certain inclusions; to provide for continuation in office
- 6 of current members; to provide for related matters; to provide effective dates; to repeal
- 7 conflicting laws; and for other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

- 9 SECTION 1.
- 10 An Act creating the Board of Commissioners of Lincoln County, approved
- 11 February 25, 1949 (Ga. L. 1949, p. 1228), as amended, particularly by an Act approved
- 12 April 5, 2002 (Ga. L. 2002, p. 4909) and by an Act approved March 27, 2012
- 13 (Ga. L. 2012, p. 4561), is amended by revising Section 2 as follows:

14 "SECTION 2.

15 (a) For the purpose of electing members of the board of commissioners, Lincoln County shall be divided into five commissioner districts. Commissioner Districts 1, 2, 3, and 4 16 17 shall be and correspond to those four numbered districts described in Appendix A attached 18 to and made a part of this Act and further identified as 'User: Lincoln Co. Plan Name: LincolnCCSB-2022 Plan Type: Local'. Commissioner District 5 shall be comprised of the 19

- 20 entire geographic area of Lincoln County.
- 21 (b)(1) For the purposes of such plan:

- 22 (A) The term 'VTD' shall mean and describe the same geographical boundaries as 23 provided in the report of the Bureau of the Census for the United States decennial 24 census of 2020 for the State of Georgia. The separate numeric designations in a district 25 description which are underneath a VTD heading shall mean and describe individual Blocks within a VTD as provided in the report of the Bureau of the Census for the 26 27 United States decennial census of 2020 for the State of Georgia; and
 - (B) Except as otherwise provided in the description of any district, whenever the description of any district refers to a named city, it shall mean the geographical boundaries of that city as shown on the census maps for the United States decennial census of 2020 for the State of Georgia.
 - (2) Any part of Lincoln County which is not included in any district described in subsection (a) of this section shall be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2020 for the State of Georgia.
 - (3) Any part of Lincoln County which is described in subsection (a) of this section as being included in a particular district shall nevertheless not be included within such district if such part is not contiguous to such district. Such noncontiguous part shall instead be included within that district contiguous to such part which contains the least

population according to the United States decennial census of 2020 for the State of Georgia."

42 SECTION 2.

- 43 (a) Those members of the Board of Commissioners of Lincoln County who are serving as
- such on the effective date of this Act and any person selected to fill a vacancy in any such
- office shall continue to serve as such members until the regular expiration of their respective
- 46 terms of office and upon the election and qualification of their respective successors.
- 47 (b) Commissioner Districts 1, 2, 3, and 4, as they exist immediately prior to the effective
- 48 date of this Act, shall continue to be designated as Commissioner Districts 1, 2, 3, and 4,
- 49 respectively, but as newly described under this Act, and on and after the effective date of this
- Act, such members of the board serving from those former commissioner districts shall be
- 51 deemed to be serving from and representing their respective districts as newly described
- 52 under this Act.

SECTION 3.

- 54 The provisions of this Act relating to and necessary for the regular election in 2022 of
- 55 members of the Board of Commissioners of Lincoln County shall become effective upon its
- approval by the Governor or upon its becoming law without such approval; and this Act shall
- 57 otherwise become effective January 1, 2023.

SECTION 4.

59 All laws and parts of laws in conflict with this Act are repealed.
