A BILL TO BE ENTITLED AN ACT

- 1 To amend Code Section 40-5-26 of the Official Code of Georgia Annotated, relating to
- 2 applications of minors, so as to provide for specific individuals who may sign an application
- 3 for an instructional permit or driver's license for a minor; to amend Chapter 1 of Title 51 of
- 4 the Official Code of Georgia Annotated, relating to general provisions for torts, so as to
- 5 provide for certain immunity for individuals who sign an application for an instructional
- 6 permit or driver's license for a minor; to provide for related matters; to repeal conflicting
- 7 laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **SECTION 1.**

- 10 Code Section 40-5-26 of the Official Code of Georgia Annotated, relating to applications of
- minors, is amended by revising subparagraph (a)(1)(A) as follows:
- 12 "(A) Signed and verified by the father, mother, or guardian of the applicant before a
- person authorized to administer oaths or, in the event there is no parent or guardian, by
- another responsible adult, or for an applicant committed to the care, custody, or control
- of the Department of Human Services, by an employee of the Division of Family and
- 16 <u>Children Services of the Department of Human Services, an employee of a child-caring</u>
- institution or a group-care facility, as such terms are defined in Code Section 49-5-3,
- or a caregiver, as such term is defined in Code Section 49-5-3; or"
- 19 SECTION 2.
- 20 Chapter 1 of Title 51 of the Official Code of Georgia Annotated, relating to general
- 21 provisions for torts, is amended by adding a new Code section to read as follows:
- 22 <u>"51-1-55.</u>
- 23 (a) As used in this Code section, the term:
- 24 (1) 'Caregiver' shall have the same meaning as set forth in Code Section 49-5-3.

23	(2) Child-carring institution shall have the same meaning as set forth in Code Section
26	<u>49-5-3.</u>
27	(3) 'Group-care facility' shall have the same meaning as set forth in Code Section 49-5-3.
28	(b) An employee of the Division of Family and Children Services of the Department of
29	Human Services, a child-caring institution, or a group-care facility or a caregiver who is
30	under contract with the Department of Human Services who makes a careful and sensible
31	decision that maintains the safety and best interests of a minor shall not be subject to any
32	civil liability, penalty, licensing sanction, or other detrimental action for signing an
33	application for such minor's instructional permit or driver's license as provided for in Code
34	Section 40-5-26."
