A RESOLUTION

- 1 Recognizing February 7, 2023, as Skin Cancer Awareness Day at the state capitol; and for
- 2 other purposes.
- 3 WHEREAS, melanoma and other skin cancers are one of the most preventable, yet fatal,
- 4 forms of cancer, accounting for more than 50 percent of all cancers combined, including
- 5 breast, lung, and prostate cancer; and
- 6 WHEREAS, one American dies of melanoma every 67 minutes, and the estimated total
- 7 direct annual cost of melanoma treatment exceeds \$290 million; and
- 8 WHEREAS, it is reported that of the one million newly diagnosed cases of melanoma and
- 9 other skin cancers each year, an estimated 10,710 people will die; and
- 10 WHEREAS, the objectives of the Georgia Society of Dermatology and Dermatologic
- 11 Surgery are to promote the highest possible standards of clinical practice, education, and
- 12 research in dermatologic medicine and surgery and related disciplines; to promote the public
- 13 interest relating to dermatology; to advocate on behalf of dermatology and high-quality
- 14 patient care; and to provide a forum for the discussion of medical and practice related
- 15 problems; and

16 WHEREAS, the Atlanta Dermatological Association is an association of dermatologists

- 17 practicing in the greater Atlanta area, dedicated to promoting the highest possible standards
- 18 of clinical practice, education, and research in dermatologic medicine, surgery, and related
- 19 disciplines while promoting the public interest relating to dermatology and providing a forum
- 20 for the discussion of medical and practice related problems; and
- 21 WHEREAS, the mission of the Skin Cancer Awareness Network Foundation is to create
- 22 public awareness of the dangers of excessive or unprotected direct exposure to the sun or
- both and to educate people about preventive safety measures to avoid or lessen the chances
- 24 of developing melanoma or one of the other preventable skin cancers; and
- 25 WHEREAS, it is necessary to encourage public awareness of the dangers of excessive or
- 26 unprotected direct exposure to the sun and to educate people about preventive safety
- 27 measures to avoid or lessen the chances of developing melanoma or one of the other
- 28 preventable skin cancers while still being able to safely enjoy outdoor activities.
- 29 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
- 30 the members of this body encourage all Georgians to have a greater awareness of the risks
- of skin cancer and the need for early diagnosis of skin cancer and recognize February 7,
- 32 2023, as Skin Cancer Awareness Day at the state capitol.
- 33 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is authorized
- and directed to make appropriate copies of this resolution available for distribution to the
- 35 Georgia Society of Dermatology and Dermatologic Surgery, the Atlanta Dermatological
