## A RESOLUTION

- 1 Requesting that the Gwinnett County Board of Commissioners work to ease the traffic woes
- 2 facing its constituents and listen to citizens' demands to increase mass transit options; and
- 3 for other purposes.
- 4 WHEREAS, traffic congestion in the metropolitan Atlanta region is an ongoing problem that
- 5 negatively impacts the lives of Georgia residents and visitors; and
- 6 WHEREAS, Gwinnett County stands as one of Georgia's most populated counties, and the
- 7 number of county residents continues to grow; and
- 8 WHEREAS, among the counties of the metropolitan Atlanta area, Gwinnett is being left
- 9 behind by neighboring counties where providing mass transit options have become priorities;
- 10 and
- WHEREAS, mass transit options are vital to ensure economic prosperity of people and the
- 12 neighborhoods in which they live, work, and play; and
- 13 WHEREAS, Metropolitan Atlanta Rapid Transit Authority (MARTA) provides efficient rail
- service throughout Atlanta, giving passengers with access to its trains the freedom to travel
- 15 without the burden of a car or traffic; and
- 16 WHEREAS, extending the MARTA rail line into Gwinnett County to the Gwinnett Center
- 17 Arena would not only help alleviate traffic congestion in the area but also spur economic
- 18 growth; and
- 19 WHEREAS, many citizens in Gwinnett County would welcome the addition of rail service
- 20 as a transportation option and have voiced their frustration with elected officials who do not
- 21 advocate for their desire to join MARTA; and

22 WHEREAS, the first step in determining whether Gwinnett County should join MARTA and

- 23 decrease the time drivers are stuck in traffic must come from the Gwinnett County Board of
- 24 Commissioners; and
- 25 WHEREAS, town halls and other public forums should be held to allow for public input and
- 26 comment on the topic of allowing the voice of the people to be heard with a vote to join
- 27 MARTA.
- 28 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
- 29 the members of this body request that members of the Gwinnett County Board of
- 30 Commissioners hold public forums or provide for other similar means to gauge Gwinnett
- 31 County voters' desire to join the Metropolitan Atlanta Rapid Transit Authority.
- 32 BE IT FURTHER RESOLVED that, should the Gwinnett County Board of Commissioners
- 33 determine that a majority of residents desire to expand the MARTA rail line into the county,
- 34 the board is urged to take immediate action so that a vote of the people may be taken during
- 35 the 2016 elections.
- 36 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is authorized
- 37 and directed to make an appropriate copy of this resolution available to the Gwinnett County
- 38 Board of Commissioners.
