- 1 Honoring the victims in the Atlanta missing and murdered children case; and for other
- 2 purposes.
- 3 WHEREAS, the State of Georgia and our nation lost many innocent children in what is
- 4 known locally as the "missing and murdered children case" as the result of a series of
- 5 murders committed in Atlanta, Georgia, from the summer of 1979 until the spring of 1981;
- 6 over the two-year period, many African American children, adolescents, and adults were
- 7 killed; and
- 8 WHEREAS, the people of the State of Georgia mourn for those persons whose lives were
- 9 taken, and they will always remember the victims and their families; and
- 10 WHEREAS, the following victims and their families will remain in the thoughts and prayers
- 11 of Georgians:

- 36 WHEREAS, this tragedy shocked the nation's consciousness, brought much needed attention
- 37 to the seriousness of child victimization, and forever changed the response by law
- 38 enforcement agencies to reports of missing children; and
- 39 WHEREAS, the case sparked a national conversation on improving mental health services
- 40 and providing for the safety of our children; and
- 41 WHEREAS, every year in the United States, an estimated 800,000 children are reported
- 42 missing, more than 2,000 children each day; of that number, 200,000 are abducted by family
- 43 members and 58,000 are abducted by nonfamily members, for whom the primary motive is
- sexual; each year, 115 children are the victims of the most serious abductions; they are taken
- 45 by nonfamily members and either murdered, ransomed, or taken with the intent to keep them
- 46 permanently.
- 47 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
- 48 the members of this body commit to honor the memory of the 28 innocent and precious lives
- 49 lost in Atlanta, Georgia, by working to enact laws to provide for the safety of our children.
- 50 BE IT FURTHER RESOLVED that the State of Georgia is committed to continue to work
- 51 until adequate laws are passed to protect our children and the adults caring for them from
- 52 tragedies.
