A RESOLUTION

- 1 Recognizing February 5, 2019, as Tourism, Hospitality, and Arts Day at the state capitol; and
- 2 for other purposes.
- 3 WHEREAS, the Georgia Department of Economic Development and its partners are hosting
- 4 Tourism, Hospitality, and Arts Day at the state capitol on February 5, 2019, in celebration
- 5 of the vital contributions of Georgia's tourism industry professionals; and
- 6 WHEREAS, this annual gathering of tourism industry professionals is an event that
- 7 acknowledges the importance of these industries, celebrates the prior year, and looks to the
- 8 year ahead; and
- 9 WHEREAS, travel and tourism to Georgia generated more than \$63.2 billion in total tourism
- output, including direct, indirect, and induced impact for an increase of 4 percent in 2017;
- 11 and
- 12 WHEREAS, Georgia's tourism industry supported more than 462,000 jobs, directly or
- indirectly, for travel and other industries, making up 10.6 percent of all nonfarm jobs in the
- 14 state; and
- 15 WHEREAS, travel and tourism directly generated over \$3.2 billion in state and local tax
- 16 revenue in 2017; and
- 17 WHEREAS, total tourism demand now stands 40 percent higher than its pre-recession level;
- 18 and
- 19 WHEREAS, every Georgia household would need to be taxed an additional \$885 per year
- 20 to replace the tourism industry tax revenues received by state and local governments in 2017;

WHEREAS, Georgia welcomed a record 107.7 million visitors in 2017, an increase of 2

- 26 individually impact every county, city, and community in Georgia; spur job creation; and
- 27 provide Georgians with a vibrant quality of life that sets Georgia apart from other states; and
- 28 WHEREAS, the state's tourism industry professionals have played a vital role in
- 29 strengthening Georgia's economic prosperity, as well as making Georgia a great place to
- 30 vacation, do business, and live; and
- 31 WHEREAS, it is abundantly fitting and proper that the outstanding contributions of this
- 32 extraordinary industry and its magnificent workers be appropriately recognized.
- 33 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
- 34 the members of this body commend the tourism industry and recognize February 5, 2019, as
- 35 Tourism, Hospitality, and Arts Day at the state capitol.
