A RESOLUTION

- 1 Recognizing and commending the YMCA of Metro Atlanta on its 160th anniversary; and for
- 2 other purposes.
- 3 WHEREAS, since 1858, the YMCA of Metro Atlanta has grown from a small group of men
- 4 in pre-Civil War downtown Atlanta to a 160,000 member organization with 18 branch
- 5 operations in 12 counties, working to help people of all ages and backgrounds reach their full
- 6 potential; and
- 7 WHEREAS, the YMCA's work is advanced through partnerships with local governments,
- 8 public school systems, hospital systems, local colleges and universities, the corporate and
- 9 philanthropic communities, and other nonprofits; and
- 10 WHEREAS, as Atlanta's oldest nonprofit, more than 250,000 children and adults are served
- 11 through the YMCA of Metro Atlanta, nearly 20,000 young people have fun while developing
- 12 new life skills at YMCA summer camps, nearly 2,000 teens serve others and learn life and
- leadership skills through the YMCA's teen programs, and more than 6,000 children are cared
- 14 for and developed academically through YMCA early childhood learning and after-school
- 15 programs; and
- 16 WHEREAS, 25,000 Metro Atlanta children receive free lunches when school is out during
- 17 the winter and summer months through the organization's Anti-Hunger Campaign; and
- 18 WHEREAS, Metro Atlanta YMCA's resident camps at Camp High Harbour at Lake Burton
- and at Lake Allatoona help young people ages 7 to 14 develop independence and helps older
- 20 teens develop leadership skills; and
- 21 WHEREAS, there are four strategic focus areas for the YMCA of Metro Atlanta's work:
- 22 ensure school readiness, improve academic achievement, empower healthy living, and
- 23 inspire civic leadership; and

- 26 WHEREAS, generous individuals, foundations and corporate partners contribute each year
- 27 so that all individuals or families who need financial assistance are able to participate in the
- 28 YMCA's life-changing programs at some level; and
- 29 WHEREAS, throughout its history, the YMCA has evolved to meet the changing unmet
- 30 needs of Metropolitan Atlanta, and continues to shape Atlanta's future for good; and
- 31 WHEREAS, the YMCA of Metro Atlanta has been an important part of the Atlanta region's
- 32 history for 160 years and it is abundantly fitting and proper that the outstanding
- 33 accomplishments of this extraordinary nonprofit be appropriately recognized.
- 34 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
- 35 the members of this body commend the YMCA of Metro Atlanta for its many valuable
- 36 contributions on behalf of the citizens of Georgia and recognize it on the occasion of its
