A RESOLUTION

- 1 Recognizing and commending the University of Georgia chapter of Blue Key National
- 2 Honor Society on the occasion of Georgia Blue Key Day 2019 at the state capitol; and for
- 3 other purposes.
- 4 WHEREAS, the University of Georgia chapter of Blue Key National Honor Society was
- 5 founded at the University of Georgia in 1926 by Blue Key National Honor Society; it has
- 6 served the students, faculty, and staff of the university and the Athens community for 93
- 7 continuous years and is the third oldest chapter of Blue Key National Honor Society in the
- 8 United States; and
- 9 WHEREAS, the mission of the University of Georgia chapter of Blue Key National Honor
- 10 Society is to honor academic and leadership excellence at the University of Georgia in all
- 11 colleges and schools; and
- 12 WHEREAS, numerous United States senators; United States representatives; cabinet
- 13 members; federal judges; governors; lieutenant governors; constitutional officers; Supreme
- 14 Court Justices; Georgia Court of Appeals judges; Georgia General Assembly members,
- 15 including two current Georgia state representatives, the Honorable Matthew Wilson and the
- 16 Honorable Houston Gaines; and members of the Board of Regents of the University System
- 17 of Georgia are members of the University of Georgia Blue Key chapter; and
- 18 WHEREAS, the University of Georgia Blue Key chapter endeavors to highlight and applaud
- 19 outstanding leaders in public service to the State of Georgia and its people by inducting
- 20 honorary members, including the Honorable Spencer Frye, and by conferring the Blue Key
- 21 Service Award to recognize the contributions of distinguished leaders to the university, state,
- 22 and nation, including the Honorable David Ralston, the Honorable Jan Jones, and the
- 23 Honorable Terry England; and

24 WHEREAS, the Blue Key National Honor Society motto of "Serving I Live" is well and
25 truly exemplified by the University of Georgia student members of Blue Key National Honor
26 Society; and

27 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this
28 remarkable and distinguished University of Georgia honor society be recognized
29 appropriately.
