A RESOLUTION

- 1 Recognizing and commending Evander Holyfield as an ambassador of good will; and for
- 2 other purposes.
- 3 WHEREAS, Evander Holyfield, born the youngest of nine children on October 19, 1962, is
- 4 an American former professional boxer who competed between 1984 and 2011; and
- 5 WHEREAS, he reigned as the undisputed champion in both the cruiserweight and
- 6 heavyweight division, being the first and only boxer to date to do so and thereby earning the
- 7 nickname of "The Real Deal"; and
- 8 WHEREAS, Holyfield is the only four-time world heavyweight champion, having held the
- 9 unified WBA, WBC, and IBF titles from 1990 to 1992, the WBA and IBF titles again from
- 10 1993 to 1994, the WBA title a third time from 1996 to 1999, the IBF title a third time from
- 11 1997 to 1999, and the WBA title for a fourth time from 2000 to 2001; and
- 12 WHEREAS, in 1996, he defeated Mike Tyson and reclaimed the WBA title, in what was
- 13 named by *The Ring* magazine the Fight of the Year and Upset of the Year; and

14 WHEREAS, this made Holyfield the first boxer since Muhammad Ali to win a world

- 15 heavyweight title three times; and
- 16 WHEREAS, Holyfield won a 1997 rematch against Tyson, which saw the latter disqualified
- in round three for biting off part of Holyfield's ear; and
- 18 WHEREAS, Holyfield retired in 2014 with a record of 44-10-2, earning his rank as number
- 19 77 on *The Ring*'s list of the 100 greatest punchers of all time; in 2002, the magazine named
- 20 him the 22nd greatest fighter of the past 80 years; and
- 21 WHEREAS, he currently ranks number 91 in BoxRec's ranking of the greatest pound for
- 22 pound boxers of all time, and Boxing Scene ranked him the greatest cruiserweight of all time;
- 23 and
- 24 WHEREAS, On June 11, 2017, he was inducted into the International Boxing Hall of Fame
- 25 in Canastota, New York; and
- 26 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this
- 27 extraordinary individual be appropriately recognized.
- 28 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
- 29 the members of this body recognize and commend Evander Holyfield as an ambassador of
- 30 good will for his many outstanding accomplishments and extend sincere best wishes for
- 31 future health and happiness.
