- 1 Honoring and commending Mr. C.H. Andy Kim for his successful efforts in uniting Korean
- 2 and American communities; and for other purposes.
- 3 WHEREAS, Mr. C.H. Andy Kim, chairman and CEO of the Duluth-based CORMAN Global
- 4 Group, served as president of the Korea Southeast United States Chamber of Commerce and
- 5 while there, was instrumental in developing a number of successful programs and launched
- 6 the chamber's new website; and
