## A RESOLUTION

- 1 Honoring the life of Mr. J. Marion Thomason and dedicating a road in his memory; and for
- 2 other purposes.
- 3 WHEREAS, our nation's security continues to rely on patriotic men and women who put
- 4 their personal lives on hold in order to place themselves in harm's way to protect the
- 5 freedoms that all United States citizens cherish; and
- 6 WHEREAS, Mr. J. Marion Thomason was born in Toccoa, Georgia, on June 27, 1926, the
- 7 beloved son of Gartrell and Lou Ella Thomason; and
- 8 WHEREAS, a graduate of Toccoa High School, he served as a guardian of this nation's
- 9 freedom and liberty with the United States Army 8th Air Force, valiantly and courageously
- 10 defending America during World War II; and
- 11 WHEREAS, he earned a degree in civil engineering from Clemson Agricultural College and
- 12 began his distinguished career in the civil engineering program of the State Highway
- 13 Department; and
- 14 WHEREAS, after many years of service with the state, Mr. Thomason joined Tugalo
- 15 Construction Company, where he served as a partner until his retirement; and
- 16 WHEREAS, a man of deep and abiding faith, Mr. Thomason was an active member of First
- 17 Baptist Church of Toccoa, where he served as a deacon and participated in several mission
- 18 trips; and
- 19 WHEREAS, his leadership and guidance were instrumental to numerous organizations,
- 20 including the Lions Club, Stephens County Food Bank, Georgia Mountain Regional
- 21 Development Center, and Toccoa Masonic Lodge; and

22 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished

- 23 Georgian be recognized appropriately by dedicating a road in his honor.
- 24 NOW, THEREFORE, BE IT RESOLVED AND ENACTED BY THE GENERAL
- 25 ASSEMBLY OF GEORGIA that the portion of State Route 17 from GA 123 to Rose Lane
- 26 in Stephens County is dedicated as the J. Marion Thomason Memorial Highway.
- 27 BE IT FURTHER RESOLVED that the Department of Transportation is authorized and
- 28 directed to erect and maintain appropriate signs dedicating the J. Marion Thomason
- 29 Memorial Highway.
- 30 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is authorized
- 31 and directed to make appropriate copies of this resolution available for distribution to the
- 32 family of Mr. J. Marion Thomason and to the Department of Transportation.
