## A RESOLUTION

- 1 Recognizing Mr. Roy E. Herrington and dedicating a road in his honor; and for other
- 2 purposes.
- 3 WHEREAS, Mr. Roy E. Herrington has long been recognized by the citizens of this state for
- 4 the vital role that he has played in leadership and his deep personal commitment to the
- 5 welfare of the citizens of Georgia; and
- 6 WHEREAS, a native of Baxley, Georgia, Mr. Herrington graduated from Appling County
- 7 High School and Marsh Business College and served as a guardian of this nation's freedom
- 8 and liberty with the United States Air Force; and
- 9 WHEREAS, he served as the District 1 representative on the Georgia Department of
- 10 Transportation Board from 2005 to 2010 and was honored as Appling County Citizen of the
- 11 Year in 1981; and
- 12 WHEREAS, his leadership has been instrumental to numerous organizations including
- 13 Appling County Chamber of Commerce Board of Directors, Baxley State Bank Board of
- 14 Directors, Community Bank of Georgia Board of Directors, Baxley Kiwanis Club, Appling
- 15 County Industrial Development Authority, and Appling County Stockman's Association; and
- 16 WHEREAS, Mr. Herrington's significant organizational and leadership talents, his
- 17 remarkable patience and diplomacy, his keen sense of vision, and his sensitivity to the needs

- 25 NOW, THEREFORE, BE IT RESOLVED AND ENACTED BY THE GENERAL
- 26 ASSEMBLY OF GEORGIA that the portion of State Route 4/US 1 through Appling County
- 27 is dedicated as the Roy E. Herrington Highway.
- 28 BE IT FURTHER RESOLVED that the Department of Transportation is authorized and
- 29 directed to erect and maintain appropriate signs dedicating the Roy E. Herrington Highway.
- 30 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is authorized
- 31 and directed to make appropriate copies of this resolution available for distribution to
- 32 Mr. Roy E. Herrington and to the Department of Transportation.
