A RESOLUTION

- 1 Commending the Judicial Council and the Administrative Office of the Courts on 40 years
- 2 of developing and improving statewide court administration; and for other purposes.
- 3 WHEREAS, the judiciary is one of the cornerstones of a democratic system of government,
- 4 a branch that our Georgia Constitution establishes as a co-equal partner with the executive
- 5 and legislative branches; and
- 6 WHEREAS, faith in our government rests in large part on the public's trust and confidence
- 7 in our courts; and
- 8 WHEREAS, efficient and effective courts are vital to protecting and serving Georgia's
- 9 increasing population and making our state an attractive location to conduct business; and
- 10 WHEREAS, the Judicial Council is the policy-making body for all of Georgia's courts, and
- 11 the Administrative Office of the Courts is its administrative arm; and
- 12 WHEREAS, since its founding in 1973, the Administrative Office of the Courts has provided
- 13 business and management expertise and professional services to all classes of courts to
- 14 promote the effective and efficient administration of justice throughout Georgia; and
- 15 WHEREAS, the Administrative Office of the Courts, as staff of the Judicial Council,
- 16 provides subject matter expertise on policy, furnishes information technology and human
- 17 resources, and produces journals, study reports, court manuals, and legislative updates; and
- 18 WHEREAS, the Administrative Office of the Courts' research addressing caseloads,
- 19 courthouse facilities, juries, court budgets, and juvenile justice services has led to
- 20 constructive change in Georgia's court system at the state and local levels; and

- supported the development of problem-solving and accountability in courts, have worked to
- 23 establish or support numerous councils, committees, boards, and commissions that benefit
- 24 citizens by developing strategies and recommendations on judicial education, court
- 25 technology, alternative dispute resolution, and so much more; and
- 26 WHEREAS, during the past four decades, the Judicial Council and the Administrative Office
- 27 of the Courts have pursued their mission to ensure consistency in the statewide court system,
- 28 to improve court operations, and to enhance communication among Georgia's judiciary.
