A RESOLUTION

1 Recognizing and commending the Elbert County Chamber of Commerce on the occasion of
2 its 100th anniversary; and for other purposes.

3 WHEREAS, the Elberton Chamber of Commerce was established on September 11, 1924,
4 when 60 members of the business community gathered in the Elk's Hall at 8 o'clock p.m., for
5 an incorporation meeting and banquet; and

6 WHEREAS, on April 26, 1962, by vote of the membership, the Elberton Chamber of
7 Commerce changed its name to the Elbert County Chamber of Commerce, reflecting the
8 entity's change of purpose to represent and promote the entire county; and

9 WHEREAS, since its inception, the Elbert County Chamber of Commerce has been
10 dedicated to developing entrepreneurial interests and to promoting cooperation between
11 businesses and residents; and

12 WHEREAS, the Elbert County Chamber of Commerce has been a pillar of strength and
13 support for the local community, fostering economic growth, promoting commerce, and
14 enhancing the quality of life for a century; and

15 WHEREAS, the chamber has been a driving force in advancing the interests of businesses
16 both large and small, promoting innovation, and creating a vibrant and prosperous
17 environment for commerce to thrive; and

18 WHEREAS, the Elbert County Chamber of Commerce has consistently demonstrated a
19 commitment to community development, advocating for policies that enhance the economic
20 well-being of the region, and collaborating with local businesses, government agencies, and
21 civic organizations to create a more robust and resilient community; and

22 WHEREAS, the chamber has played a pivotal role in fostering a sense of unity and
23 cooperation among businesses and residents, contributing significantly to the overall success
24 and prosperity of Elbert County; and

25 WHEREAS, the chamber's century-long legacy of service, advocacy, and leadership has had
26 a profoundly positive impact on the economic and social fabric of Elbert County.

27 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
28 the members of this body recognize and commend the dedication, hard work, and vision of
29 the leaders, staff, and members of the Elbert County Chamber of Commerce for their
30 unwavering commitment to the betterment of the community; acknowledge the remarkable
31 achievements and contributions of the Elbert County Chamber of Commerce throughout its
32 illustrious 100-year history; and extend warmest congratulations to the Elbert County
33 Chamber of Commerce on its 100th anniversary.
