Georgia Legislative Black Caucus; and

WHEREAS, her numerous accolades include being honored by the Georgia Historical
Records Advisory Council for her Legislative Advocacy for establishing an agricultural
museum and receiving the 2015 We Are Clayton Living Legend Award and the 2015 Alpha
Kappa Alpha Capitol Legislator of the Year Award; and

WHEREAS, Senator Seay is united in love and marriage to Walter Seay, and the couple isblessed with two remarkable children and four beloved grandchildren; and

WHEREAS, she has served with honor and distinction, and her vision and unyieldingcommitment will be sorely missed upon the occasion of her retirement; and
