A RESOLUTION

- 1 Recognizing and commending the City of Roswell's craft beer breweries; and for other
- 2 purposes.
- 3 WHEREAS, the State of Georgia has been ranked as the top state in the country in which to
- 4 do business for five consecutive years; and
- 5 WHEREAS, due to the improved legal climate induced by recent changes to the Georgia
- 6 Code, many new businesses opening in Georgia have been craft beer breweries; and
- 7 WHEREAS, the number of craft beer breweries in Georgia has tripled in just five years and
- 8 the annual production of craft beer in Georgia exceeds 400,000 barrels; and
- 9 WHEREAS, Georgia's craft breweries have a nearly \$2 billion economic impact on the state;
- 10 and
- WHEREAS, a craft brewery is a small, generally independent establishment that uses
- 12 traditional yet innovative ingredients and techniques; and
- 13 WHEREAS, a successful craft brewer must combine the science of biology and chemistry
- with the art of good business practices within the hospitality industry; and
- 15 WHEREAS, in 2018, the City of Roswell is home to four such unique breweries, Gate City
- 16 Brewing Company, Abbey of the Holy Goats, From the Earth Brewing Company, and
- 17 Variant Brewing Company; and
- 18 WHEREAS, the Roswell Convention and Visitor's Bureau, along with these four breweries,
- 19 has a collaborative effort called "Roswell Brews" that helps position Roswell as a brewery
- 20 destination and offers a unique commemorative glass to visitors who have experienced all
- 21 four breweries; and

- and food in a friendly atmosphere where people bond and memories are made; and
- 24 WHEREAS, the success of craft brewers provides jobs, builds community spirit, supports
- 25 nonprofit fundraising, enhances leisure time, counsels customer responsibility and safety, and
- 26 promotes tourism and economic development in Georgia.
- 27 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
- 28 the members of this body recognize and commend Gate City Brewing Company, Abbey of
- 29 the Holy Goats, From the Earth Brewing Company, and Variant Brewing Company for their
- 30 contributions to the enjoyment and benefit of the citizens in Roswell and to the art and
- 31 science of craft beer brewing in the State of Georgia.
