A RESOLUTION

- 1 Recognizing October 9, 2019, as PANDAS Awareness Day at the state capitol; and for other
- 2 purposes.
- 3 WHEREAS, pediatric acute-onset neuropsychiatric syndrome (PANS) and pediatric
- 4 autoimmune neuropsychiatric disorder associated with streptococcal infection (PANDAS)
- 5 create the sudden onset of obsessive-compulsive disorder, tic disorders, and/or restrictive
- 6 eating in children, causing previously healthy and emotionally adjusted children to
- 7 experience severe anxiety and emotional disturbances; and
- 8 WHEREAS, children with PANS and PANDAS tend to manifest some of the following
- 9 symptoms: tics or other abnormal movements, severe separation anxiety, generalized anxiety,
- 10 irritability, aggression, personality changes, attention deficit hyperactivity disorder, marked
- deterioration in learning and school performance, and developmental regression, including
- 12 regression in handwriting; and
- 13 WHEREAS, children with PANS and PANDAS may experience a moderate to dramatic
- 14 improvement with antibiotics, intravenous immunoglobulin treatment, or plasmapheresis;
- 15 and
- WHEREAS, researchers at the National Institute of Mental Health (NIMH) are currently
- 17 engaged in extensive research and testing on how to effectively treat PANS and PANDAS;
- 18 and
- 19 WHEREAS, researchers at Moleculera Labs at the University of Oklahoma have developed
- 20 PANS and PANDAS blood testing procedures; and
- 21 WHEREAS, the University of Arizona and Banner Health System in Arizona have opened
- 22 the first Centers for Post-Infectious Autoimmune Encephalopathy, providing insurance based

23 access to expert care and consultative services for general and subspecialist pediatricians

- around the country; and
- 25 WHEREAS, the deep medical and bioscience resources in Georgia make our state well
- 26 situated to meaningfully contribute to best medical practices, research, and medical
- 27 technology to advance the early diagnosis and treatment of children with PANS and
- 28 PANDAS; and
- 29 WHEREAS, the NIMH estimates one in 200 children have PANS or PANDAS, meaning
- 30 these diseases affect roughly 15,000 children in Georgia; and
- 31 WHEREAS, many general pediatricians, nurse practitioners, and pediatric subspecialists are
- 32 not familiar with the most current diagnostic criteria and treatment guidelines for these
- 33 disorders; and
- 34 WHEREAS, in addition to lack of access to treating providers, many insurers do not cover
- 35 treatment for PANS and PANDAS, which can cost many tens of thousands of dollars,
- 36 placing it out of reach for most families; and
- 37 WHEREAS, the Southeastern PANS/PANDAS Association is a Georgia based nonprofit
- organization dedicated to expanding access to expert, insurance based care for children and
- 39 families suffering from PANS and PANDAS in this region; and
- 40 WHEREAS, it is imperative that there be greater public awareness of this serious health issue
- 41 among parents, policymakers, and medical providers in Georgia.
- 42 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
- 43 the members of this body recognize October 9, 2019, as PANDAS Awareness Day at the
- 44 state capitol.
- 45 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is authorized
- and directed to make appropriate copies of this resolution available for distribution to the
- 47 public and press.
