- 1 Honoring the lives of MSG Mark Allen and SGT Mike Stokely and dedicating a road in their
- 2 memory; and for other purposes.
- 3 WHEREAS, our nation's security continues to rely on patriotic men and women who put
- 4 their personal lives on hold in order to place themselves in harm's way to protect the
- 5 freedoms that all United States citizens cherish; and
- 6 WHEREAS, MSG Mark Allen and SGT Mike Stokely served together as guardians of this
- 7 nation's freedom and liberty with the Georgia Army National Guard, 108th Cavalry 48th
- 8 Brigade; and
- 9 WHEREAS, these Loganville, Georgia, residents were together on May 15, 2005, when their
- unit saw heavy enemy action in Iraq's Triangle of Death; and
- 11 WHEREAS, on August 16, 2005, at the age of 23, SGT Stokely made the ultimate sacrifice
- when he was killed in action near Yusufiyah south of Bagdad; and

13 WHEREAS, despite the tragic loss of his friend SGT Stokely and other members of his

- 14 platoon, MSG Allen rejoined an infantry unit and was deployed to Afghanistan in 2009 when
- 15 he sustained a serious head injury in a firefight with enemy forces; and
- 16 WHEREAS, after a ten-year battle with his injuries and numerous surgeries, MSG Allen
- passed away on October 12, 2019; and
- 18 WHEREAS, MSG Allen and SGT Stokely demonstrated a deep personal commitment to
- 19 protecting democracy and a willingness to sacrifice their own personal safety and comfort
- 20 to ensure the well-being of their fellow man; and
- 21 WHEREAS, their selfless service to this nation and unyielding commitment to protecting the
- 22 people and ideals of the United States will long be remembered and appreciated; and
- 23 WHEREAS, MSG Allen and SGT Stokely embodied the spirit of service, willing to find
- 24 meaning in something greater than themselves, and it is abundantly fitting and proper that
- 25 these remarkable and distinguished Georgians be recognized appropriately by dedicating a
- 26 road in their memory.
- 27 NOW, THEREFORE, BE IT RESOLVED AND ENACTED BY THE GENERAL
- 28 ASSEMBLY OF GEORGIA that the portion of State Route 81 from US 78 to the Newton
- 29 County line is dedicated as the MSG Mark Allen and SGT Mike Stokely Memorial Highway.
- 30 BE IT FURTHER RESOLVED that the Department of Transportation is authorized and
- 31 directed to erect and maintain appropriate signs dedicating the MSG Mark Allen and SGT
- 32 Mike Stokely Memorial Highway.
