- 12 found their way through the United States; and
- WHEREAS, by establishing a women's leadership program, founding and publishing an

- 15 American Association of University Women, and creating the "Women of Georgia Project,"
- 16 Dr. Faroki served as a stalwart champion of women's rights and equality; and
- 17 WHEREAS, her passion for education led to innumerable accomplishments and
- 18 achievements, including serving as head of school at the Galloway School and as
- 19 chairwoman of Georgia Federation of Democratic Women's Education Committee; and
- 20 WHEREAS, Dr. Farokhi coordinated curriculum development for more than 50 degree
- 21 programs at Georgia State University's College of Education; and
