

House Resolution 444 (AS PASSED HOUSE AND SENATE)

A RESOLUTION

1 Dedicating certain portions of the state highway system; repealing a portion of a resolution
2 dedicating portions of the state highway system approved on May 3, 2016 (Ga. L. 2016,
3 p. 698); repealing a portion of a resolution dedicating certain portions of the state highway
4 system as approved on May 9, 2017 (Ga. L. 2017, p. 825); and for other purposes.

5 **PART I**

6 WHEREAS, Mr. Willie Thomas Murray has long been recognized for the vital role he played
7 in leadership and his deep personal commitment to the welfare of the citizens of Georgia; and

8 WHEREAS, Mr. Murray served as a guardian of this nation's freedom and liberty with the
9 United States military during World War II; and

10 WHEREAS, he was a leader in Lincoln County, where he served as a charter member and
11 president of Twilight Improvement Association, a clearing-house for the presentation,
12 review, and study of problems facing county citizens; and

13 WHEREAS, during his years of service, the association received federal funds for emergency
14 food and medical services for county residents, and he was instrumental in establishing a
15 county-wide transportation program for senior citizens; and

16 WHEREAS, a man of deep and abiding faith, Mr. Murray served as chairman of the board
17 of trustees of Thankful Baptist Church and was a member of the Beulah Volunteer Fire
18 Department; and

19 WHEREAS, he provided scholarships for six Lincoln County college students and conducted
20 several voter registration drives and voter forums; and

21 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
22 Georgian be recognized appropriately by dedicating a bridge in his honor.

23 **PART II**

24 WHEREAS, Lieutenant Hugh L. Moore was born on August 17, 1918, the beloved son of
25 Mr. and Mrs. L.B. Moore; and

26 WHEREAS, a native of Nashville, Georgia, Lt. Moore graduated from the University of
27 Georgia in 1938 and served as a guardian of this nation's freedom and liberty as a pilot with
28 the United States Armed Forces during World War II; and

29 WHEREAS, he flew at least eight missions over Germany, participated in the Battle of
30 Midway as a pilot of a Flying Fortress bomber, and went missing in action over enemy
31 territory in Europe on July 28, 1942; and

32 WHEREAS, Lt. Moore's bravery and courage were recognized with an Air Medal with
33 Oak Leaf Cluster and a Purple Heart; and

34 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
35 Georgian be recognized appropriately by dedicating a bridge in his memory.

36 **PART III**

37 WHEREAS, a native of Atlanta, Georgia, Mr. James Harold Shepherd is a pioneer in the
38 road construction industry as a founding member of the Shepherd Construction Company;
39 and

40 WHEREAS, Mr. Shepherd began his illustrious career in road construction at the age of 14,
41 after his father sent to him to drive alone to Louisiana to build a levee for the WC Shepherd
42 Company; and

43 WHEREAS, over the last six decades, Mr. Shepherd and his family have been responsible
44 for constructing hundreds of miles of interstate highways in Georgia and several surrounding
45 states, as well as thousands of miles of city and county streets; and

46 WHEREAS, at one time, Mr. Shepherd managed 15 asphalt plants across Georgia,
47 North Carolina, and South Carolina and holds the patent on the "rumble roller" which marks
48 the pavement edge on roads; and

49 WHEREAS, his leadership and vision were instrumental as president of the Georgia Asphalt
50 Paving Association and the Georgia Highway Contractors Association; and

51 WHEREAS, a man of great philanthropy and generosity, Mr. Shepherd is a co-founder and
52 founding board member of the Shepherd Center, a private, not for profit hospital that is
53 internationally renowned for specialized treatment, research, and rehabilitation for spinal
54 cord and brain injuries, multiple sclerosis, spine and chronic pain, and other neuromuscular
55 conditions; and

56 WHEREAS, he has been recognized with numerous honors and accolades, including a
57 Lifetime Achievement Award from the Georgia Highway Contractors Association, the
58 AAPM&R Distinguished Public Service Award, the *Atlanta Business Chronicle's*
59 Health-Care Heroes Award, and the 2016 Christopher Reeve Spirit of Courage Award from
60 the Dana and Christopher Reeve Foundation; and

61 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
62 Georgian be recognized appropriately by dedicating a road in his honor.

63 **PART IV**

64 WHEREAS, Mr. Horace L. Dunahoo came from a family with deep roots in the field of land
65 surveying; and

66 WHEREAS, Mr. Dunahoo's passion for land surveying began as a young boy and was said
67 to have been inspired by his uncle, Lucious House, who served as a county surveyor in
68 Barrow County, Georgia, in the early 1900s; and

69 WHEREAS, Mr. Dunahoo was appointed by Governor Ellis Arnold to survey the county line
70 dividing Gwinnett and DeKalb counties; and

71 WHEREAS, a well-respected surveyor in both Georgia and South Carolina, Mr. Dunahoo
72 surveyed the 32 mile line known as the Old Hightower Indian Trail and prepared maps that
73 defined the line for future generations; and

74 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
75 Georgian be recognized appropriately by dedicating a bridge in his memory.

76 **PART V**

77 WHEREAS, the State of Georgia lost one of its finest citizens and most dedicated law
78 enforcement officers with the tragic passing of Sergeant David P. Land on March 26, 2003;
79 and

80 WHEREAS, Sergeant Land began his career in law enforcement in 1990 as an Atlanta police
81 officer and later went on to join the Stone Mountain Police Department where he worked
82 until 1997 when he was hired by the Forsyth County Sheriff's Office; and

83 WHEREAS, this dedicated law enforcement officer's life was cut short from injuries he
84 received in a motorcycle crash en route to a call for service, just two days after he was
85 promoted to the rank of sergeant; and

86 WHEREAS, Sergeant Land exhibited extraordinary devotion to duty, outstanding loyalty,
87 fine leadership, and meticulous attention to detail in all of his duties.

88 **PART VI**

89 WHEREAS, our nation's security continues to rely on patriotic men and women who put
90 their personal lives on hold in order to place themselves in harm's way to protect the
91 freedoms that all United States citizens cherish; and

92 WHEREAS, current and former members of the United States military have demonstrated
93 a deep personal commitment to protecting democracy and a willingness to sacrifice their own
94 personal safety and comfort to ensure the well-being of their fellow man; and

95 WHEREAS, the Purple Heart is awarded to members of the armed forces who are wounded
96 by an instrument of war in the hands of the enemy and posthumously to the next of kin in the
97 name of those who are killed in action or die of wounds received in action; and

98 WHEREAS, these brave men and women serve as guardians of this nation's freedom and
99 liberty and have diligently and conscientiously undergone intensive and rigorous training in

101 WHEREAS, it is important that Purple Heart recipients are thanked for their selfless service
102 to this nation and honored for their unyielding commitment to protecting the people and
103 ideals of the United States; and

104 WHEREAS, these individuals embody the spirit of service, willing to find meaning in
105 something greater than themselves, and it is abundantly fitting and proper that the
106 outstanding accomplishments and sacrifices of these remarkable and distinguished
107 Americans be honored appropriately.

109 WHEREAS, Mr. Jesse C. Long has long been recognized by the citizens of this state for the
110 vital role that he has played in leadership and his deep personal commitment to the welfare
111 of the citizens of Georgia; and

113 to study to become a minister; and

121 committee to the Gwinnett Chamber of Commerce and he was honored as the organization's
122 Citizen of the Year in 1981; and

123 WHEREAS, it is abundantly fitting and proper that the extraordinary accomplishments of
124 this distinguished Georgian be appropriately recognized by dedicating an interchange in his
125 honor.

315 Warehouse Services of Albany and Thomasville and served as owner of Chokey Plantation

332 wonderful children, Sheridan, Meridith, and Jim; ten incredible grandchildren, Shauna,

360 NOW, THEREFORE, BE IT RESOLVED AND ENACTED BY THE GENERAL
361 ASSEMBLY OF GEORGIA that the bridge over New Ford Creek on Highway 79 in
362 Lincoln County is dedicated as the Willie Thomas Murray Memorial Bridge.

363 BE IT FURTHER RESOLVED AND ENACTED that the bridge on Nashville Tifton
364 Highway/State Route 125 between the Virgil T. Barber Bridge and the City of Nashville in
365 Berrien County is dedicated as the Lieutenant Hugh L. Moore Memorial Bridge.

366 BE IT FURTHER RESOLVED AND ENACTED that the portion of State Route 9 between
367 Peachtree Battle Avenue and the Amtrak Peachtree Station in Fulton County is dedicated as
368 the J. Harold Shepherd Parkway.

369 BE IT FURTHER RESOLVED AND ENACTED that the bridge on State Route 11 at the
370 Barrow/Walton County line is dedicated as the Horace L. Dunahoo Memorial Bridge.

371 BE IT FURTHER RESOLVED AND ENACTED that the portion of State Route 20 from

374 BE IT FURTHER RESOLVED AND ENACTED that U.S. Highway 27 through Stewart,
375 Randolph, Clay, and Early counties is dedicated as the Purple Heart Highway.

376 BE IT FURTHER RESOLVED AND ENACTED that the interchange at Interstate 85 and
377 Indian Trail Road in Gwinnett County is dedicated as the Jesse C. Long Interchange.

378 BE IT FURTHER RESOLVED AND ENACTED that the bridge on State Route 36 over the
379 Flint River in Upson County is dedicated as the Carey Ellerbee Memorial Bridge.

380 BE IT FURTHER RESOLVED AND ENACTED that this body hereby joins in honoring
381 United States military veterans and dedicates the interchange at Interstate 20 and
382 Exit 78/Sigman Road in Rockdale County as the Walk of Heroes/Veterans Interchange.

383 BE IT FURTHER RESOLVED AND ENACTED that the intersection of McFarland Road
384 and Jenkins Road in Walker County is dedicated as the Jasper W. "JW" Dodd, Jr., Memorial
385 Intersection.

386 BE IT FURTHER RESOLVED AND ENACTED that the intersection of Happy Valley Road
387 and Battlefield Parkway in Walker County is dedicated as the Ben Napier Memorial
388 Intersection.

389 BE IT FURTHER RESOLVED AND ENACTED that the intersection of Highway 193 and

391 Memorial Intersection.

392 BE IT FURTHER RESOLVED AND ENACTED that the bridge on McDonough Road at

418 of the Samuel L. and LaTanya Jackson Highway.

419 BE IT FURTHER RESOLVED that the Department of Transportation is authorized and
420 directed to erect and maintain appropriate signs dedicating the road facilities named in this
421 resolution.

422 BE IT FURTHER RESOLVED that the Department of Transportation is authorized to
423 correct any errors in the spelling of names included in this resolution without further action
424 from the General Assembly.

425 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is authorized
426 and directed to make appropriate copies of this resolution available for distribution to the
